DLA Energy's Tanker Operations Branch worked closely with Military Sealift Command to arrange a commercial tanker to tanker lightering operation of DLA owned product at the Port of Ulsan, South Korea, in late November.

This is the first time DLA Energy requested lightering between two, long-term chartered, U.S. flagged, commercial vessels. This operation was a huge success in the demonstration of an often-advertised capability to support Warfighter contingency requirements.

Due to the success, three more lightering evolutions are planned in FY21 to support warfighter requirements.

Scott served as Senior Associate General Counsel and Deputy Chief Counsel, Administrative and International Law Division, HQ DLA Office of General Counsel, and Chief Counsel, Defense National Stockpile Center, DLA, as well as numerous other legal positions during his more than 30 years of government service with the U.S. Army and DLA.

Pam Serino was honored for 35 years of federal service by Brig. Gen. Canlas at a small informal ceremony in December. As the Quality and Technical director

and chemist, Pam's accomplishments included elevating the importance of fuel quality awareness to the senior levels of the DoD. She oversaw quality assurance, quality surveillance, product technology, measurement, standardization and laboratory support for DLA Energy fuel products.

Pam began her federal career in 1985 as an environmental scientist at Aberdeen Proving Grounds, Maryland. She was the first DoD woman recognized for outstanding service in aviation fuels quality by the National Petroleum Management Association during its 2018 annual conference.
