## **NEW CONTRACTOR (MANUFACTURER, DEALER, AND DISTRIBUTOR) REQUIREMENTS FOR FSG 53 CRITICAL SAFETY ITEMS**

As of November 2023, Defense Logistics Agency (DLA) solicitations for a distinct population of FSG 53 (fasteners) NIINs identified as Critical Safety Items (CSI) include two new technical requirements, both of which are outlined at:

# REMINDER TO PRIORITIZE RATED ORDERS



This notification is being issued to raise awareness and ensure orders rated under the Defense Priorities and Allocation System (DPAS) are properly prioritized in accordance with the DPAS rating system (see 15 CFR part 700).

The DPAS rating will appear at the top of Page 1 of the order. There are two levels of priority for rated orders established by the DPAS, identified by the rating symbols "DO" or "DX" followed by a two digit program code (e.g., DOA1 or DXA1).

As a reminder, and in accordance with 15 CFR 700.14:

(a) A person must schedule operations, including the acquisition of all needed production items, in a timely manner to satisfy the delivery requirements of each rated order. Modifying production or delivery schedules is necessary only when required delivery dates for rated orders cannot otherwise be met.

(b) DO rated orders must be given production preference over unrated orders, if necessary to meet required delivery dates, even if this requires the diversion of items being processed or ready for delivery against unrated orders. Similarly, DX rated orders must be given preference over DO rated orders and unrated orders.

Examples:

If a person receives a DO rated order with a delivery date of June 3 and if meeting that date would mean delaying production or delivery of an item for an unrated order, the unrated order must be delayed. If a DX rated order is received calling for delivery on July 15 and a person has a DO rated order requiring delivery on June 2 and operations can be scheduled to meet both deliveries, there is no need to alter production schedules to give any additional preference to the DX rated order. However, if business operations cannot be altered to meet both the June 3 and July 15 delivery dates, then the DX rated order must be given priority over the DO rated order.

In addition, a person must use rated orders with suppliers to obtain items needed to fill a rated order. The person must use the priority rating indicated on the customer's rated order, except as otherwise provided in 15 CFR 700 or as directed by the Department of Commerce.

Example:

If a person is in receipt of a DOA3 rated order for a navigation system and needs to purchase semiconductors for its manufacture, that person must use a DOA3 rated order to obtain the needed semiconductors.

The priority rating must be included on each successive order placed to obtain items needed to fill a customer's rated order. Therefore, the inclusion of the rating will continue from contractor to subcontractor to supplier throughout the entire supply chain.

# DLA AUTOMATED RECORDS TRACEABILITY (DART) PLATFORM

DLA is in the initial stages of developing the DLA Automated Records Traceability application to provide DLA suppliers with a secure and easy-to-use platform to upload support documentation. DART will be accessible to a wide variety of approved users including suppliers, DLA personnel, the Defense Contract Management Agency, and DLA customers.

Support documentation typically consists of required data that demonstrates compliance with technical manufacturing requirements, product testing, traceability, air worthiness, and other applicable criteria. Such documentation is typically required when responding to the requirements of a solicitation or when fulfilling the requirements of an awarded contract. Today, suppliers submit this documentation along with the item or through email or mail. Examples include:

- Federal Aviation Administration (FAA) Form 8130-3, Certificate of Conformance (CoC) equivalent, European Union Aviation Safety Agency (EASA) Form 1, or Transport Canada Civil Aviation (TCCA) Form One for delivered part requiring FAA approval in the civil aviation sector in compliance with 14 CFR part 21, 'Certification Procedures for Parts and Products'
- Supply Chain Traceability Documentation
- DLA Form 918, Traceability/Test Documentation for FSC5961 Semiconductors and FSC5962, Electronics Microcircuits
- Manufacturer CAGE

The launch of DART is tentatively scheduled for Spring 2024.

The first DART application will likely be for all FAA items.

Suppliers responding to and/or supplying DLA with FAA parts may participate in the testing phase of DART in early 2024. Those interested in the test phase are encouraged to contact DLA requesting test participation at [DLADART@dla.mil](mailto:DLADART@dla.mil). Space will likely be limited.

Suppliers that have received a DLA award in the past 12 months for an FAA part will be contacted by DLA as the database nears completion to facilitate pre-release DART sign-up and provide further instruction for use of the DART database.

# DLA NEEDS YOUR HELP TO IMPROVE CONTRACT ON-TIME DELIVERY

It is critically important to adhere to the terms and conditions of contracts and meet established contract delivery dates (CDDs). DLA depends on expeditious contract award and timely contractor delivery to achieve mission success, and delivery delinquencies reduce warfighter readiness. We are asking our industry partners to quickly respond to solicitations and provide the most aggressive but realistic delivery times when submitting quotes. We also ask suppliers to take the following steps to help better ensure CDDs are met:

1. **Be Proactive:** Please submit Post-Award Requests (PARs) in the DLA Internet Bid Board System (DIBBS) website when there is a need to communicate with contract administrators. This allows for tracked and timely responses to inquiries. PARs can be submitted at [www.dibbs.bsm.dla.mil](http://www.dibbs.bsm.dla.mil) under the section titled, "Awards." Suppliers must have a DIBBS account to submit PARs. PARs are assigned to a contract administrator who can assist with the action requested. When submitting a DIBBS PAR, please ensure you are assigning the proper PAR reason codes to expedite attention and ensure timely responses. Inform the assigned contract administrator as soon as possible of any challenges your company is facing to delivery on time. This includes expected supply chain issues, unforeseen emergencies, or issues with subcontractors.

Under special contractor arrangements such as Prime Vendor contracts, direct communication with Tailored Logistics Support Specialists or on-site-assigned DLA personnel is still the most effective means of communication.

2. **Be Realistic:** Quoting realistic CDDs is vital so DLA can posture itself to meet the needs of our military service customers. It is important to coordinate with your subcontractors and suppliers far enough in advance to meet the CDD. If issues arise that prevent you from meeting the proposed CDD after contract award, notify your contract administrator immediately using PARs.

3. **Help DLA Perform Better:** We continually strive to improve our processes for our suppliers, such as making updates to PARs to make it more user friendly. As you communicate with contract administrators, please let us know how and where we can improve.

4. **Vendor Shipment Module (VSM):** Please use VSM for the most up-to-date shipments being made directly to customers: <https://vsm.distribution.dla.mil>.

To improve the resolution process when contacting our helpdesks:

- Include the CAGE code in all requests.
- Read instructions provided thoroughly.
- Follow all steps in the instructions received.
- Provide information as requested.
- Do not send duplicate requests.
- Allow at least 24 hours for a response (weekend/holiday responses may be delayed longer).

## **DIBBS CONUS/OCONUS ACCESS:**

The July 6, 2023 DIBBS User Agreement Terms and Conditions states, *"If the address of this company, as registered in the U.S. Government System for Award Management (SAM), is a U.S. address, I agree that I will not access DIBBS outside the United States or U.S. territories without prior approval from DLA."*

AND

*"If the address of this company, as registered in the U.S. Government System for Award Management (SAM), is an address outside of the U.S., I agree that I will not access DIBBS outside of the country in which I am registered without prior approval from DLA."*

To request approval, please send an email with the following subject line, "Request CONUS/OCONUS DIBBS Access CAGE #####" to [DIBBS\\_TC\\_MONITOR@DLA.MIL](mailto:DIBBS_TC_MONITOR@DLA.MIL)." Suppliers do not have permission to access DIBBS from outside the U.S. until an approval email from the Terms & Conditions Monitor is received. Please be aware that if approved, this does NOT grant you access to cFolders while OCONUS, which is always prohibited.

## **DIBBS Proxy Use:**

The July 6, 2023 DIBBS User Agreement Terms and Conditions states, "I agree that no user account will use any means to mask their internet usage/access to DIBBS (for example, a Virtual Private Network (VPN))."

## **CYBER SECURITY REMINDER:**

# KEY INFORMATION REGARDING YOUR DIBBS ACCOUNT (CONT.)

What constitutes as IP masking?

Please see below tables with IP masking definitions, that will result in DIBBS account suspension, as this is continually monitored.

PROXY_TYPE	Description
"?"	Not determined to be a proxy.
Anonymous	Actual IP address of client is not available. Includes services that change location to beat DRM, TOR points, temporary proxies and other masking services.
Corporate	Generally considered harmless, but location can be a concern. Can identify if multiple users are proxied through a central location or locations, and thus share a single network-apparent IP address.
Edu	Proxied users from an educational institution.
Hosting	Address belongs to a hosting facility and is likely to be a proxy as end users are not typically located in a hosting facility.
Public	Multiple users proxied from a location allowing public Internet access.
Transparent	Actual IP address of client is available via HTTP headers, though value not necessarily reliable (i.e., it can be spoofed).

PROXY_DESCRIPTION	Description
Cloud	Enables ubiquitous network access to a shared pool of configurable computing resources.
Cloud-Security	A host accessing the Internet via a web security and data protection cloud provider. Example providers with this type of service are Zscaler, Scansafe, and Onavo.
DNS	A proxy used by overriding the client's DNS value for an endpoint host to that of the proxy instead of the actual DNS value.
Tor Exit	The gateway nodes where encrypted/anonymous Tor traffic hits the Internet.
Tor Relay	Receives traffic on the Tor network and passes it along. Also referred to as "routers."
VPN	Virtual private network that encrypts and routes all traffic through the VPN server, including programs and applications.
Web-Browser	This value will indicate connectivity that is taking place through mobile device web browser software that proxies the user through a centralized location. This type of proxy connectivity falls within our 'hosting' proxy-type designation, thus the new proxy description response will be returned. A couple of examples of this type of connectivity are Opera mobile browsers and UCBrowser.
