I. AUTHORITY: Approval of the Director, Defense Logistics Agency (DLA).

III. Pursuant to cited authority and effective March 14, 2004, the changes in DLA Support Services (DSS) organizational alignment are as follows:

A. The DSS Corporate Planning Staff Directorate (DSS-P) is disestablished and its missions, personnel, resources, administration and functions are transferred as follows:

1. The Strategic Management System that encompasses the Enterprise Strategic Plan, Balanced Scorecard, Business Plans, and all other enterprise planning functions to include Joint Vision 2020 will be transferred to the Director, Enterprise Transformation (DT). All of the missions, personnel, resources, and functions will also transfer.

2. The DLA Continuity of Operations (COOP) and the DLA Critical Infrastructure Protection (CIP) will be transferred to the DSS Business Management Staff Directorate (DSS-B) and be renamed as the Contingency Planning Division (DSS-BP). All of the missions, personnel, resources, and functions will also transfer.

3. All of the missions and functions of the DLA Organization, Missions and Functions, and General Orders will transfer to DSS-B under the DSS General Services Division (DSS-BG).

B. The following are the organizational alignment changes in the DSS Quality of Life Staff Directorate (DSS-Q):

1. Both the Quality of Life Policy Division (DSS-QP) and the Quality of Life Operations Division (DSS-QO) in the DSS-Q Staff Directorate are disestablished and the personnel, resources, missions, functions, and administration are reorganized, realigned and incorporated into four new divisions. The positions identified in DSS-QO will continue to be supported with appropriated funds.

2. The following four new divisions are established and aligned under the DSS-Q Staff Directorate: Family Support Services Division (DSS-QF); Morale, Welfare and Recreation Division (DSS-QM); Child and Youth Services Division (DSS-QC); and General Support Division (DSS-QG).



C. The following are the organizational alignment changes in the DSS Command Security Staff Directorate (DSS-S):

1. The Information Security/Intelligence Division (DSS-SI) will be renamed the Intelligence/Special Programs Division and will retain the office symbol (DSS-SI).

2. The Physical Security/Law Enforcement Division (DSS-SP) will be renamed the Security Operations Division (DSS-SO). The Security Operations Branch (DSS-SPO), will be renamed the Headquarters Security Operations Branch (DSS-SOO) and aligned under DSS-SO. The Security Policy Branch (DSS-SPP) is disestablished but the functions are realigned and incorporated into DSS-SO.


3. The Communications Security Division (DSS-SA) is disestablished and its functions will be transferred to the Intelligence/Special Programs Division (DSS-SI).

4. The Personnel Security Division (DSS-SC) is established and aligned under DSS-S.

5. The Security Plans/Policy/Education and Awareness Division (DSS-SE) is established and aligned under DSS-S.

IV. Administrative services and support will be provided by HQ DLA organizations as appropriate.
