1. Authority:

Secretary of Defense (Installation and Logistics) Memorandum, dated 10 December 1964, Subject: Base Closures and Reduction.

2. Pursuant to cited authority the following actions are effective on the dates indicated:

a. Effective 1 July 1965:

(1) The Defense Personnel Support Center (DPSC) is established as a primary level field activity of the Defense Supply Agency and is located at Philadelphia, Pa. 19101.

(2) The mission and functions of the Defense Clothing & Textile Supply Center (DCTSC) are transferred to the DPSC and the DCTSC is disestablished.

(3) The centralized stock control functions in support of the DSSC are transferred from the Defense Construction Supply Center (DCSC) to the DPSC.

b. Effective 10 July 1965, the mission and functions of the Defense Subsistence Supply Center (DSSC) are transferred to the DPSC, and the DSSC is disestablished.

c. Effective 31 July 1965, the mission and functions of the Defense Medical Supply Center (DMSC) are transferred to the DPSC, and the DMSC is disestablished.

d. The following appointments are terminated:

(1) MAJOR GENERAL OLIVER C. HARVEY, 038776, USA, as Commander, DCTSC and COLONEL J. E. HERBOLD, JR., 07716, USMC as Deputy Commander, DCTSC, effective 1 July 1965.

(2) MAJOR GENERAL RAY J. LAUX, 042102, USA, as Commander, DSSC effective 10 July 1965.

(3) BRIGADIER GENERAL CHARLES H. GINGLES, 020920, USA, as Commander, DMSC, effective 15 July 1965 and COLONEL JESSE N. BUTLER, 026983, USA, as Deputy Commander, DMSC, effective 31 July 1965.


e. MAJOR GENERAL OLIVER C. HARVEY, 038776, USA is appointed
