I. Effective 1 Mar 81:

A. The following are disestablished as HQ DLA Management Support Activities of the Chief, Communications Division, DLA-WC:

1. DLA Eastern Regional Telecommunications Office (DERTO).
2. DLA Central Regional Telecommunications Office (DCRTO).
3. DLA Western Regional Telecommunications Office (DWRTO).

B. The following are established as HQ DLA Management Support Activities of the Chief, Telecommunications Division, DLA-ZT:

1. DERTO located at Richmond, Virginia.
2. DCRTO located at Columbus, Ohio.
3. DWRTO located at Alameda, California.

C. DLA General Orders No. 35-74, dated 12 Aug 74, is rescinded.

II. Under the management, direction and control of the Chief, Telecommunications Division, DLA-ZT, the Chiefs, DERTO, DCRTO and DWRTO are responsible for providing information, advice, and assistance to DLA field activities within their assigned regions including planning, programming, engineering, maintaining, testing and accepting telecommunications systems, facilities and services.

III. The geographical areas serviced by the Regional Telecommunications Offices are as follows:

A. DERTO - The States of Maine, Vermont, New Hampshire, New York, Massachusetts, Connecticut, Rhode Island, Pennsylvania, New Jersey, West Virginia, Maryland, Delaware, District of Columbia, Virginia, North Carolina, South Carolina, Georgia, and Florida.

B. DCRTO - The States of North Dakota, Minnesota, Wisconsin, Michigan, South Dakota, Nebraska, Iowa, Illinois, Indiana, Ohio, Kansas, Missouri, Kentucky, Oklahoma, Arkansas, Tennessee, Louisiana, Mississippi, and Alabama.

C. DWRTO - The States of Washington, Oregon, Idaho, Montana, California, Wyoming, Nevada, Utah, Colorado, New Mexico, Arizona, and Texas.

IV. Administrative support for DERTO, DCRTO and DWRTO will be provided by the Commanders, DGSC, DCSC and DSR-P, respectively. In addition, personnel support for DWRTO will be provided by the Commander, DBTC.
