GENERAL ORDER
NO. 12 - 83

I. Authority: ASD(MRA&L) Memorandum, 23 May 83, Subject: Defense Retail Interservice Support (DRIS) Program.

II. Defense Base Operations Analysis Office (DBOAO):

A. Pursuant to cited authority and effective 1 October 1983, the Defense Base Operations Analysis Office (DBOAO) is established as a Management Support Activity (MSA) of the Office of the Secretary of Defense (OSD).

B. Under the direction of the Assistant Secretary of Defense (Manpower, Reserve Affairs and Logistics), the Defense Base Operations Analysis Office is responsible for:

1. Promoting effective and efficient management of Department of Defense installations by monitoring, coordinating and reviewing efficiency and economy programs.
2. Recommending changes for improved operations.

C. Administrative support will be provided to DBOAO by the Commander, DLA Administrative Support Center (DASC), Defense Logistics Agency.

III. Southeastern Base Operations Analysis Office (SBOAO):

A. Pursuant to cited authority and effective 1 October 1983, the Southeastern Base Operations Analysis Office (SBOAO) is established in Atlanta, Georgia, as a subordinate office of the Defense Base Operations Analysis Office (DBOAO).

B. Under the direction of DBOAO, the Southeastern Base Operations Analysis Office is responsible for:

1. Promoting efficiency and economy in base operating support in the Southeastern CONUS through the development, evaluation and recommendation of areas of study having potential for mutual support.
2. Assisting local study groups in the geographical area of responsibility with studies being considered or undertaken. Providing recommended actions on completed studies for Service/Agency evaluation.
3. Leading selected regional studies extending beyond a JIRSG area or affecting more than one JIRSG.


C. Administrative support will be provided to SBOAO by the Commander, DCASR Atlanta.
