I. AUTHORITY: Approval of the Commander, Defense Contract Management Command (DCMC).

II. REFERENCES:

III. Pursuant to cited authority and effective January 30, 2000, the changes in DCMC organizational alignment are as follows:

A. The MOCAS Transition Assistance Center (DCMCC-M) is established. DCMCC-M will be responsible for providing guidance, assistance and policy change recommendations to facilitate the migration of minimal contract data to SPS/DPPS. The resources of the DCMC Overhead Center (DCMCC-E) located at Fort Belvoir, with the exception of the mission and resources assigned to the DCMC Overhead Center Contractor Insurance Pension Review teams, will transfer to DCMCC-M.

B. The DCMC Overhead Center (DCMCC-E) is renamed the DCMC Contractor Insurance Pension Center (DCMCC-E). The mission, objectives and related resources of the Contractor Insurance Pension Review teams will remain in DCMCC-E.

IV. The organizations above will report directly to the Director, Contract Business Operations Team (DCMC-OA) for policy guidance, operational direction and performance appraisals. Additionally, organizational assignment for the DCMC Defense Corporate Executives (DCEs) will continue under the districts they are currently assigned. DCEs will report to DCMC-OA for technical control, policy guidance, operational direction and performance appraisals. The DCMC Business Support Unit (DCMCC-A) will provide DCMCC-E and DCMCC-M with assistance in planning, programming and financial management.

V. Administrative support, to include civilian personnel servicing, for DCMCC-E and DCMCC-M will be provided by the Defense Contract Management District East (DCMDE), with the exception of the Director, MOCAS Transition Assistance Center (DCMCC-M). This position will be serviced by the DLA Administrative Support Center. Administrative
