## AMENDMENT OF SOLICITATION/MODIFICATION OF CONTRACT

**SPE4A2-15-R-0002 Amendment 0008**

**Continued**

The purpose of this amendment is to clarify an ambiguity that was created after the Government issued Amendment 0007 and to provide offerors an opportunity to amend their proposals as a result. To be clear, the DOD small business prime goals and the small business material spend metric identified in the solicitation are minimum requirements, which must be met in order for a proposal to be considered acceptable. The Evaluation Procedures Paragraph 2E Factor 4, Small Business Participation Plan Evaluation Approach, is amended to state: "Proposals that fail to meet either the DoD small business prime goals or the 50% small business material spend metric will be evaluated as unacceptable. Proposals that offer to exceed the DoD small business prime goals and the 50% small business material spend metric will be evaluated more favorably." The Instructions to Offerors Paragraph 2E Factor 4, Small Participation Plan, is amended to remove the text: "Provide adequate rationale if socio-economic entity goals are not met. Offerors are cautioned against only acknowledging a goal is not met, if applicable. Adequate rationale includes specific reasons why a goal is unmet and any actions being taken to increase any unmet goals." Offerors must return this signed amendment along with any change pages to their Small Business participation Plan by 21 January 2016.
