SUBJECT: Approved DLMS Change 49, Revision to DLMS Supplement (DS) 517M,

Material Obligation Validation (MOV) (Supply)

This change to the DoD 4000.25-M, Defense Logistics Management System (DLMS), reflects an administrative change to the DS 517M, MOV, required to support continued logistics operations in a DLMS/DLSS environment. A corresponding change to the Federal IC is required prior to implementation of this revision. The DS will be posted to the DLMSO web site (http://www.dla.mil/j-6/dlmso/ICs/Default.htm) immediately upon coordination/ approval from the DoD Electronic Data Interchange Standards Management Committee (EDISMC) and Logistics Functional Working.

3. REQUESTED CHANGE:

a. Title: Revision to DS 517M, MOV.

b. Description of Change: This change modifies the DS to open the 2/QTY03/10 to accommodate the unit of issue applicable to the material being validated.

c. Procedures: Revise DLMS Supplements as indicated. Yellow highlighting in the enclosure identifies changes within the contest of the DS.

4. REASON FOR CHANGE: This change is required for successful conversion between the DLSS MOV transaction and the corresponding DLMS implementation. Under the original DLMS concept the unit of issue applicable to the MOV would be resident in both the sender and receiver's systems and transmission was not considered necessary. Current thinking is that the unit of issue must be retained to support conversion and may be retained under the future DLMS.
