SUBJECT: Approved DLMS Change (ADC) 73, Revision to DLMS Supplement (DS) 527R,

Receipt, Inquiry, Response and MRA to provide for Current Functionality of the

Materiel Receipt Acknowledgement Process (Supply/MILSTRAP)

This revision to the DoD 4000.25-M, Defense Logistics Management System (DLMS), modifies the DS 527R Receipt, Inquiry, Response and MRA as shown in the attachment. This is a critical change to DS 527R necessary to correct a deficiency by providing for current functionality of the MRA process. The updated DLMS Supplement will be posted to the DLMSO web site (http://www.dla.mil/j-6/dlmso/ICs/Default.htm) within 30 days from the above date for implementation planning. DLMSO will concurrently pursue coordination/approval with the DoD Logistics Functional Working Group, the DoD Electronic Data Interchange Standards Management Committee (EDISMC), and the Federal EDI Standards Management Coordinating Committee (FESMCC) for Federal implementation conventions (IC) revisions.

The attached change to DLMS will be incorporated into the DLMS manual/supplement. NOTE: DAASC and DLA have advance authorization to employ these procedures during ongoing Business Systems Modernization (BSM) implementation; however configuration management/version control procedures must be observed allowing for sequential implementation to prevent rejection.

Approved DLMS Change (ADC) 73, Revision to DLMS Supplement 527R

Receipt, Inquiry, Response and MRA to provide for Current Functionality of the Materiel Receipt Acknowledgement Process (Supply/MILSTRAP)

2. FUNCTIONAL AREA: Supply

3. REQUESTED CHANGE:

1. **Title:** Revision to DLMS Supplement 527R, Receipt, Inquiry, Response and MRA to Provide for Current Functionality of MILSTRAP Materiel Receipt Acknowledgement (MRA) Process.

2. Description of Change:

- **a.** This change revises DS 527R to provide the capability to submit a MRA transaction without a stock or part number in support of current MRA requirements. This change will also allow for MILSTRAP MRA transactions (Document Identifier (DI) Code DRA/DRB), which are submitted with a blank stock/part number field, to process in DLMS during a mixed DLSS/DLMS environment.
- **b.** This change also provides administrative note updates to allow flexibility for adding codes for DoD use.
 - **3. Procedures:** Revise DS 527R, Receipt, Inquiry, Response and MRA as follows:

4. REASON FOR CHANGE:

- **a.** This change is necessary to support intended DLMS functionality. DS 527R does not allow for the absence of a stock/part number. This conflicts with DoD 4000.25-2-M (MILSTRAP) MRA procedures which allow for leaving the stock/part number field blank as follows: "If the stock number/part number of the item received cannot be fully entered in record positions 8-22, leave blank. If item received exceeds stock number field and is wrong item or cannot be identified leave record positions 8-22 blank and enter Discrepancy Indicator Code A in record position 63." This revision to DS 527R is necessary to accommodate this provision for a blank stock or part number field in DS 527R MRA transaction.
- **b.** This change is necessary to support DLMS/DLSS conversion. The MILSTRAP MRA transaction, DI Codes DRA and DRB submitted with a blank stock/part number field cannot be converted to DS 527R until this change is implemented.
