SUBJECT: Approved DLMS Change (ADC) 99A, Revision to DLMS Supplement (DS) 517G, GFM Validation, Data Content Correction/Clarification (Supply)

The attached change to DOD 4000.25-M, Defense Logistics Management System (DLMS), is approved for implementation. This change is primarily administrative to prepare the DS 517G for implementation.
