b. <u>ADC 1025</u>, Update of Routing Identifier Codes, DOD Activity Address Codes, Reparable/Nonreparable National Item Identification Numbers, and Combatant Command designations in the Logistics Metrics Analysis Reporting System (Staffed as PDC 481), September 12, 2012.

4. REQUESTED CHANGE(S):

a. <u>Brief Overview of Change</u>: This change identifies a methodology for identifying Department of Defense Activity Address Codes (DoDAACs) for U.S. Navy Reserve units for inclusion in appropriate LMARS Reserve reports. Per Reference 3.a. each Service is to provide either a listing or business logic to identify all DoDAACs assigned to identify Reserve units for that Service.

b. <u>Background</u>:

(1) LMARS uses Reserve units' DoDAACs to filter transactions into reports for each Service as called for in Reference 3.a.

"C4.6.5.1.5. "RESERVE" Report. To be included in the Reserve Report, the document number's Ship-To address or Consignee must be an identified Reserve DoDAAC. Note that the document numbers included in the Reserve Report are not included in the Composite Report, paragraph C4.6.5.1.1. DLA Transaction Services maintains an internal table of DoDAACs supplied by the Components that identifies Reserve unit DoDAACs." (2) ADC 1025 updated the Services' National Guard and Reserve Unit DoDAACs. Navy indicated that there were no Navy Reserve units DoDAACs. This resulted in a blank Logistics Response Time (LRT) for the Major Report Category "Reserves" (from the main LMARS Web Page) for the Navy. (See Enclosure.)

(3) Further consultation with the Navy PM PRC representative resulted in the Navy Reserve Chief-of-Staff for Logistics reviewing this issue. After research and review, Commander Naval Reserve Forces Command (COMNAVRESFORCOM) Logistics, Plans and Policies concurred with the recommendation to move forward to identify Navy Reserve DoDAACs with the use of Major Command Code NO, as currently defined in DLM 4000.25, Volume 6, Chapter 2:

"C2.4.4.2. Major Command Codes (MAJCOM). MAJCOMs allow sub-delegation of DoDAACs below the Service/Agency level. These codes are Service/Agency-created and are denoted in the DoDAAD by the header "MAJ_COMMAND." The current MAJCOMs are maintained by Transaction Services, and are published on the DoDAAD PRC webpage at www.dla.mil/j-

c. <u>Approved Change in Detail</u>: Transaction Services will update LMARS to use the Major Command Code NO for filtering Navy transactions for the Navy Reserve to produce LRT reports.

- d. <u>Revisions to DLM 4000.25 Manuals</u>: No changes to DLM 4000.25 are required.
- e. <u>Approved Transaction Flow</u>: No changes to transaction flows are required.
- f. <u>Alternatives</u>: None identified at this time.

5. REASON FOR CHANGE: LRT reports for the U.S. Navy Reserve units are not being generated by LMARS. LRT is a reportable metric provided monthly by Transaction Services. This change will enable LMARS to establish U.S. Navy Reserves' DoDAACs and to generate current, end of month Navy Reserve LRT reports

6. ADVANTAGES AND DISADVANTAGES:

a. <u>Advantages</u>: Implementation of these changes will enable LMARS to generate useful end of month LRT reports for the Navy Reserve.

b. <u>Disadvantages</u>: None identified.

7. ESTIMATED TIME LINE/IMPLEMENTATION TARGET: Transaction Services will provide implementation dates of this ADC when they become available.

8. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH IMPLEMENTATION OF THIS CHANGE: None Identified

9. IMPACT:

a. <u>New DLMS Data Elements</u>: No new DLMS data elements or changes to existing ones are required.

b. <u>Automated Information Systems (AIS)</u>: There is no impact to Component systems.

c. <u>Transaction Services</u>: Transaction Services must update the LMARS report generation code to use MAJCOM Code NO to identify Navy Reserve units.

d. <u>Non-DLM 4000.25 Series Publications</u>: Components should ensure that internal documentation reflects the use of NO to identify Navy Reserve units as appropriate.
