SUBJECT: Approved Defense Logistics Management System (DLMS) Change (ADC) 1054, Intra-DLA Revisions to Procedures and DLMS 945A Materiel Release Advice, Denial Management Code for Credit to Commercial Venture (CV) Contract Associated with DLA Disposition Services under Reutilization Business Integration (RBI) (Supply/MILSTRIP/MILSTRAP)

The attached change to Defense Logistics Manual (DLM) 4000.25, DLMS, and DLM 4000.25-2, Military Standard Transaction Reporting and Accountability Procedures (MILSTRAP), is approved for immediate intra-DLA implementation. Intra-DLA Revisions to Procedures and DLMS 945A Materiel Release Advice, Denial Management Code for Credit to Commercial Venture (CV) Contract Associated with DLA Disposition Services under Reutilization Business Integration (RBI) (Supply/MILSTRIP/MILSTRAP)

- **a.** Approved Defense Logistics Management System (DLMS) Change (ADC) 1034, Intra-DLA Revision to Procedures to Support DLMS 945A, Materiel Release Advice, Cancellation Reason Code and Denial Management Code for Redistribution Orders Associated with DLA Disposition Services under Reutilization Business Integration (RBI) (Supply/Logistics), dated October 23, 2012

## 4. REQUESTED CHANGE(S):

**a.** <u>Brief Overview of Change</u>: A new Denial Management Code must be added to the DLMS 945A (MILSTRIP Legacy Document Identifier Code (DIC) A6\_, that represents a denial of an unauthorized Commercial Venture (CV) delivery order line item. Due to the limited number of available Management Codes the expanded use of Denial Code W for RBI unique requirements is approved.

#### b. Background:

(1) The DLA Disposition Services is a worldwide presence within the Department of Defense, with disposal specialists in 14 foreign countries, two U.S. territories, and 39 states. DLA Disposition Services' mission is the execution of disposition solutions for excess military property. The Reutilization Business Integration (RBI) project will replace the Disposal

Automated Information System (DAISY) by integrating DLA Disposition Services business processes within the DLA enterprise suite of applications, including the Enterprise Business System (EBS) for material management functions and the Distribution Standard System (DSS) for warehousing/distribution functions.

- (2) Per Reference 3.b., DLA Disposition Services has a sales contract in place with a Commercial Venture (CV) firm to sell DOD surplus property. Normally, DLA Disposition Services will identify property categorized for CV and send the DLMS 846C Disposition Category Update transaction to the DLA Disposition Services Field Office to initiate processing. Upon receipt of the DLMS 846C indicating CV, the Field Office will generate the DLMS 846C Disposition Category Update Response transaction to DLA Disposition Services confirming or changing the assigned disposition category codes.
- (3) If the Controlled Property Verification Office at the Field Office determines materiel is not CV eligible, the Disposition Category Update Response transaction will contain Disposition Category Code DS (Disposal) instead of SL (Sales), as well as a disposition category change reject reason code, as published in DLA Disposition Services 4160.14, reflecting the data characteristic or reason the item will not be released to the CV contract. DLA Disposition Services will in turn send the updated DLMS 846C to the Field Office. The reject reason code will cause the Field Office to remove the property from the CV holding area at the warehouse and allow the item to be processed through ultimate disposal.
- (4) In limited situations, where a delivery order is released to the Field Office listing Disposal Turn-In Documents (DTID) to issue/ship to a CV firm, and a subsequent Reutilization/Transfer/Donation (RTD) system order is received for DTID(s) on that delivery order prior to shipment to the CV firm, a DLMS 945A Materiel Release Denial (MILSTRIP legacy DIC A6A/A6B/A61/A62) needs to be sent to DLA Disposition Services to remove the item from the delivery order and generate a systemic credit for that delivery order. A new denial management code for this scenario is required so that sales personnel at the DLA Disposition Services Field Offices have the ability to properly close-out a pick requirement for property that appears on the CV delivery order that does not qualify for issuing to CV, and expedite the denial with a systematic credit to the CV firm.
- **c.** <u>Describe Approved Change in Detail</u>: Add Denial Management Code W Unauthorized Commercial Venture Denial. For intra-DLA Disposition Services use only to indicate that the Field Office will not ship the DTID originally designated as an authorized CV. The Field Office will adjust the pick requirement for the CV firm to exclude the unauthorized CV item. DLA Disposition Services will create a systemic credit for the CV firm documentation.

## d. Revisions to DLM 4000.25 Manuals:

(1) DLM 4000.25-2 MILSTRAP, Appendix 2.6 Management Codes, Paragraph AP2.6.2 Issue Related Transactions. See Enclosure 1.

- (2) DLM 4000.25 DLMS, Volume 2 Supply, Chapter 16, add new paragraph C16.6.8.3.2.1.3.
- C16.6.8.3.2.1.3. <u>Use of DLMS 945A Materiel Release Denial for Unauthorized CV Materiel.</u> In limited situations, where a CV delivery order is released to the DLA Disposition Services Field Office listing DTIDs to issue/ship to a CV firm, and a subsequent mission essential RTD order is received for DTID(s) on that delivery order prior to shipment to the CV firm, a DLMS 945A Materiel Release Denial (MILSTRIP legacy DIC A6A/A6B/A61/A62) citing Denial Management Code W needs to be sent to DLA Disposition Services to remove the item from the delivery order and generate a systemic credit for that delivery order. Sales personnel at the DLA Disposition Services Field Offices will then have the ability to properly close-out a pick requirement for property that appears on the CV delivery order that does not qualify for issuing to CV and expedite the denial with a systematic credit to the CV firm.
  - **e. Approved Transaction Flow:** No new transactions or routing rules are required.
- **f.** <u>Alternatives</u>: Identify a current denial management code that is not currently used by RBI EBS that is appropriate for this specific situation.
- **5. REASON FOR CHANGE:** Currently available denial management codes on the DLMS 945A/document identifier code A6\_ and cancellation reason codes on the DLMS 945A/document identifier code AG6 are not appropriate for use in this specific situation. Current codes do not create a credit to the CV firm, so they are billed for property that never should have been on the delivery order in the first place. The new denial management code will ensure in systematic fashion that both a credit to the CV documentation is generated and the property is not put on a subsequent delivery order.

#### 6. ADVANTAGES AND DISADVANTAGES:

- **a.** <u>Advantages</u>: DLA Disposition Services will be able to credit the CV firm for property in a quick, efficient, and systematic method.
- **b.** <u>Disadvantages</u>: Updating the DLMS 945A Materiel Release Denial transaction will require minor coding changes in the RBI system suite (including DSS and EBS) to accommodate the mapping and processing of the new denial management code.
- **7. ESTIMATED TIME LINE/IMPLEMENTATION TARGET:** Authorized for immediate implementation.
- **8. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH IMPLEMENTATION OF THIS CHANGE:** Cost savings calculated at 76 hours a week for Sales Office and Site Personnel at an average of \$30/hour, 52 weeks a year for a total cost of \$118,560 a year in labor dollars to do causative research and manual intervention.

#### 9. IMPACT:

a. New DLMS Data Elements: No new DLMS data elements required.

- **b.** <u>Changes to DLMS Data Elements</u>: Add new Denial Management Code W to Logistics Qualifier 84. See Enclosure 2.
- **c.** <u>Automated Information Systems (AIS):</u> EBS and DSS will require minor coding changes to properly map and process the new denial management code.
- **d.** <u>DLA Transaction Services</u>: DLA Transaction Services must update the mapping for the DLMS 945A to reflect the new denial management code (or expanded use of 'W').
