4. REQUESTED CHANGE(S):

- **a. Brief Overview of Change:** This approved administrative addendum to ADC 1066C:
 - (1) Replaces approved addendum ADC 1066B in its entirety,
- (2) Updates DOD WebSDR processing to limit changes to input made to the Owner/Manager/Source of Supply data entered on the original SDR submissions. This update applies only to the SDR processing rules for Document Type 7 SDR (Customer originated, depot/lateral shipment/other) and non-quality-related Document Type R (Depot originated, redistribution order receipt),
- (3) Establishes a rule that only the DLA Distribution can change the Owner/Manager/Source of Supply data using a Reply (Transaction Set Purpose Code 11) submission when the customer leaves this field blank, or inputs an incorrect value input on the original submission, and
- (4) Causes WebSDR to suppress any future Party to Receive (Qualifier/Code PK) distribution copies (Transaction Set Purpose Code 22) to an activity that received the Reply Code 450 (Administrative closure notification. SDR information copy sent to wrong source of supply).
- (5) Adds new SDR Reply Code 948 Transaction rejected. Unauthorized change in the Owner, Manager, or Source of Supply field, to DLMS 4000.25 Volume 2 Appendix 7.28 Supply Discrepancy Report Relevant Data Elements.
- **(6)** Corrects a typo in the below paragraph c.(1).(b). that erroneously miss-numbered new Reply Code 948 as 947.

Note: The administrative updates are highlighted in green.

b. **Background**:

- (1) Under ADC 1066A (Reference 3.c.), WebSDR established new rules associated with changes to the value of the source of supply routing identifier code (RIC). The source of supply RIC may be updated by a storage activity reply transaction on a Document Type 7, non-quality-related Document Type R, or non-quality-related Document Type N (WebSDR-entered, comparable to Type R) SDR.
- (a) The most common scenario for source of supply corrections occurs when the distribution center processes a customer SDR and overlays an erroneous sentry provided by the submitter with the actual source of supply known by the Distribution Standard System (DSS) to have directed the shipment.
- **(b)** A similar situation could occur when a storage activity generates an SDR to the shipping activity after an owner/manager-directed redistribution and identifies an incorrect RIC in the source of supply field. The shipping activity may overlay the incorrect owner/manager in its reply transaction.

- (2) Upon processing a change to the source of supply RIC, WebSDR will notify the original source of supply to consider the SDR closed for that activity only (the SDR itself will remain open).
- (a) The notification to the original source of supply will take the form of an SDR reply from the DAAS RIC, SGA, citing new Reply Code 450 (Administrative Closure Notification).
- **(b)** The new source of supply may not be able to process the reply transaction containing the updated source of supply because that activity's SDR system has no record of the original SDR.
- (c) An information copy of the SDR is provided to the correct/new source of supply prior to transmitting the storage activity reply to ensure that these will process successfully.
- (3) The above process is not applicable to SDRs generated by storage activities when the action is directed to the owner/manager (e.g., Document Type 8, 9, or quality-related Type R or N). When these are generated with the incorrect owner/manager RIC, the SDR must be cancelled and resubmitted correctly.

c. Approved Change in Detail:

- (1) SDR Changes to the Owner, Manager, and Source of Supply (O/M/S) Data Input from the Original Submission.
- (a) For SDR Document Type 7, and non-quality-related Document Type R, only DLA Distribution can make updates to the O/M/S data field. If the submitter wishes to change this field, they must cancel the original SDR and submit a new SDR. Use of the Correction (Transaction Set Purpose Code (CO)) is not authorized in this scenario.
- **(b)** If any activity other than the DLA Distribution Center, which is the current action activity, tries to update or change the O/M/S field, reject the update with new Reply Code 948. WebSDR will reject transactions with new Reply Code (SDR reply code additions are shown in red bold italics).
- (c) Add new SDR Reply Code to DLMS 4000.25 Volume 2, Appendix 7.28 Supply Discrepancy Report Relevant Data Elements as shown below,
- 948 Transaction rejected. Unauthorized change in the Owner, Manager, or Source of Supply field.
- (d) Long text description of the rejection will state, "Only the current DLA Distribution Center can update the owner, manager, or source of supply field. If you need to change this field you must cancel this SDR and create a new SDR."
- (2) WebSDR Block on Distribution Copies to Reply Code 450. WebSDR will suppress any future Party to Receive (Qualifier/Code PK) distribution copies (Transaction Set

Purpose Code 22) to an activity that received the Reply Code 450 (Administrative Closure Notification. SDR information copy sent to wrong source of supply) for only Document Type 7, and R SDRs.

d. Revisions to DLM 4000.25 Manuals:

(1) Update DLMS 4000.25 Volume 2, Appendix 7.28 Supply Discrepancy Report Relevant Data Elements as shown in paragraph c.(1).(c).

Update DLM 4000.25 Volume 2, Chapter 17, Supply Discrepancy Reporting, to incorporate revised procedures as follows:

(Preceding text not shown)

C17.3.3. SDRs Resulting from Redistribution Orders (RDOs). The following procedures are applicable to DLA Distribution Centers and may be applied to other storage activities as directed by the responsible Service/Agency. Only the current DLA Distribution Center can update the owner, manager, or source of supply field. Submitters must cancel and resubmit their SDR if they need to update this field. When a storage activity receives a shipment based upon a redistribution order and the materiel is short, over, wrong, quality deficient, or otherwise discrepant the receiving activity will:

C17.3.20.4.2. If an SDR source of supply is updated to identify a different source of supply (based upon *DLA Distribution updating the owner, manager, or source of supply field using a reply* action activity reply) after an information copy was provided, to the original, an SDR closure notification (Reply Code 450 - *Administrative Closure Notification. SDR information copy sent to wrong source of supply*) will be generated by WebSDR to the originally identified source of supply so that the open record can be administratively closed. *WebSDR will suppress any future Party to Receive (Qualifier/Code PK) distribution copies (Transaction Set Purpose Code 22) to an activity that received the Reply Code 450 for only <i>Document Type 7 and R SDRs.* WebSDR will also provide an information copy (Transaction Set Purpose Code 22) of the original SDR to the newly identified source of supply (the information copy will contain the updated RIC value rather than perpetuating the original value).

- e. Approved Transaction Flow: Normal SDR process flow applies.
- **f.** Alternatives: None identified.

5. REASON FOR CHANGE:

- **a.** This change will prevent SDR submitters from updating the original O/M/S data after they create the SDR, which causes further issues downstream while processing the SDR.
- **b.** Suppressing party-to-receive copies of transactions from going to activities that received the Reply Code 450 (Administrative Closure Notification. SDR information copy sent

to wrong source of supply) will prevent activities from receiving transactions they no longer need.

6. ADVANTAGES AND DISADVANTAGES:

- **a.** <u>Advantages</u>: These new rules will ensure Component systems and DAAS can receive and properly process SDR transactions to correct activities.
 - **b. <u>Disadvantages</u>**: None noted.
- **7. ESTIMATED TIME LINE/IMPLEMENTATION TARGET:** The target implementation date is January 2020.
- 8. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH IMPLEMENTATION OF THIS CHANGE: Not able to quantify.

9. IMPACT:

- a. New DLMS Data Elements: There are no new data elements.
- b. Changes to DLMS Data Elements: There are no revised data elements.
- **c.** <u>Automated Information Systems (AIS)</u>: Revise SDR applications for revised SDR reply code list.
 - d. <u>Defense Automatic Addressing System (DAAS)</u>:
 - (1) Update WebSDR tables for revised SDR reply code list.
 - (2) WebSDR will suppress any future Party to Receive (Qualifier/Code PK) distribution copies (Transaction Set Purpose Code 22) to an activity that received the Reply Code 450 Administrative closure notification.
- **e.** Non-DLM 4000.25 Series Publications: DOD Components may need to update internal operating procedures and other published Receipt/SDR guidance.
