4. APPROVED CHANGE(S):

a. **Brief Overview of Change:** This approved change will:

- (1) Remove the duplicate reference to criteria that would preclude automated closeout in DLM 4000.25, Volume 7 (Reference 3.a.), and reference the PGI 204.804-3 automated contract closeout criteria (Reference 3.b.).
- (2) Modify the DLMS 567C to remove the ability to cancel a unilateral purchase order not accepted by the contractor.
- (3) Updated terminology to reflect the change to Procurement Integrated Enterprise Environment (PIEE).

b. Background:

- (1) ADC 1163 (Reference 3.c.) addressed the automated contract closeout process using the DLMS 567C. Specific details for this change are contained in WAWF ECP 1087 Contract Closeout Table Changes and ECP 1107 Expanded Contract Closeout Module (References 3.d. and 3.e.). The DFARS PGI 204.804-3 (Reference 3.b.) and DLM 4000.25, DLMS Volume 7, Chapter 4 (Reference 3.a.) reference the criteria to qualify a contract for the automated closeout process. To maintain integrity and reduce administrative updates, Volume 7, Chapter 4 will point to PGI 204.804-3 as the authoritative reference for automated contract closeout criteria. This change will minimize confusion regarding which FAR clauses represent contracts qualified for the automated contract closeout process.
- (2) After implementation of the automated contract closeout module, the DPC Team identified that cancellation of a unilateral purchase order would not done with a DLMS 567C. It would be accomplished by contract modification, which uses the Procurement Data Standard (PDS) or an 860 Purchase Order Change as noted in DFARS PGI 213.307-3 (Reference 3.g.)

c. Approved Change in Detail:

- (1) In Volume 7, Chapter 4, remove the reference to automated closeout eligibility criteria and point to PGI 204.804-3 (Reference 3.b.) as the single authoritative reference for the appropriate FAR clauses. See Enclosure 1.
- (2) In Volume 7, Chapter 4, revise the wording to cancel a unilateral purchase order to require a contract modification and remove that as an option in the DLMS 567C. See Enclosures 1 and 2.
- (3) In Volume 7, Appendix 1 and the DLMS 567C, remove Contract Closeout Status Report Code H "Cancelation of a unilateral purchase order not accepted by the contractor"

d. Revisions to Defense Logistics Manuals:

(1) Update Volume 7, Chapter 4, and Appendix 1 (Enclosure 1).

- **5. REASON FOR CHANGE:** Reduces duplicate sources of information.

- **a.** Advantages: Reduces the amount of time required to update information sources and reduces the probability of using incorrect FAR Clauses.

Chapter 4, Contract Completion Status Reporting Updates

C4.10.2.1. <u>CAO Issuance</u>. Those issued by the CAO:

C4.10.2.1.1. The unclosed contract status (Code D);

C4.10.2.1.2. The final contract completion statement for a small purchase (Code A);

C4.10.2.1.3. The interim contract completion statement for a large purchase (Code B); and

C4.10.2.1.4. The final contract completion statement for a large purchase (Code C).

C4.10.2.2. <u>PO Issuance</u>. The transaction issued by the PO is the contract closeout extension (Code E)

C4.10.2.3. <u>DFAS Issuance</u>. The transaction issued by DFAS is the financial contract completion statement (Code F).

C4.10.2.4. *Wide Area Work Flow (WAWF)* Invoicing, Receipt, Acceptance and Property Transfer (iRAPT). The final contract completion statement for automated contract closeouts (Code G); and

C4.11. <u>AUTOMATED CONTRACT CLOSEOUT</u>

C4.11.1. <u>Purpose</u>. The Automated Contract Closeout is a systemic process in the Contract Closeout module accessible from the *Procurement Integrated Enterprise Environment* (*PIEE*) Wide Area Work Flow (WAWF) eBusiness Suite home screen for Electronic Document Access (EDA) users with an active 'Upload/Inactive Contracts' role. This will apply where notifications are distributed using data from WAWF eBusiness Suite, Invoicing, Receipt, Acceptance and Property Transfer (iRAPT), EDA, and MyInvoice.

C4.11.2. <u>Authority</u>. As permitted by FAR 4.804-5(a) and DFARS *PGI* 204.804-3, automated contract closeout allows a system to initiate and execute the closeout action.

- C4.11.3. <u>Eligibility Requirements</u>. Contracts to be closed must not be administered by the Defense Contract Management Agency (DCMA) unless the "Admin By DoDAAC" matches a DoDAAC on an exception list. A new Contracting Officer (KO) role <u>was will be</u> created within the Automated Contract Closeout module to enable contracts to be placed on hold. **DFARS PGI 204.804-3 contains the criteria that a contract must meet to be automatically closed.** Under the Authority identified in C4.11.2, contracts qualify for the automated closeout process if the contract meets the following requirements:
- C4.11.3.1. Identified in the Procurement Data Standards (PDS) extensible markup language (XML) data as firm fixed priced,
- C4.11.3.2. Does not exceed a total contract value of \$500,000 (inclusive of exercised options),
 - C4.11.3.3. Does <u>not</u> have a hold on the contract placed by the Contracting Officer,
- C4.11.3.4. Does not contain any of the following clauses requiring administrative action at closeout:
 - FAR 52.211-11 Liquidated Damages—Supplies, Services, or Research

Development.

- FAR 52.216 7 Allowable Cost and Payment.
- FAR 52.227-9 Refund of Royalties.
- FAR 52.227-11 Patent Rights—Ownership by the Contractor.
- FAR 52.227 13 Patent Rights Ownership by the Government.
- FAR 52.232 16 Progress Payments.
- FAR 52.232-29 Terms for Financing of Purchases of Commercial Items.
- FAR 52.232-30 Installment Payments for Commercial Items.
- FAR 52.232 32 Performance Based Payments.
- FAR 52.245 1 Government Property.
- FAR 52.248-1 Value Engineering.
- C4.11.3.5. Use of PDS data from EDA enables review of applicable clauses, which is then coupled with evidence of submission from iRAPT and payment of the final invoice in MyInvoice
- C4.11.3.6. The following conditions are necessary for automated closeout using this capability:
 - Contract must utilize WAWF for deliveries and payments.
 - Contract must be available in EDA as PDS.
 - Entitlement systems must feed WAWF invoice status.

C4.11.6.2. Simultaneous with establishment of a new parameterized window, **WAWF** iRAPT-will generate a DLMS 567C Cancellation of a previously submitted automated contract closeout action. This will be identified by 1/BC07/020 Code 2 (Change (Update)), 1/CS05/050 Code G (Final contract completion statement for contract closeouts) and 1/LQ02/110 Code K (Cancellation). This will notify EDA that additional documents were received and a new 60-day parameterized window is started. This ensures that the contract is not open in one system and closed in another system.

C4.11.7.2. The 1/N1/030 segment precedes the 1/C/050 loop, and with two iterations, carries the Code FR (from) and the Code TO (to); this will be WAWF-iRAPT in the FR and the AAI in the TO.

C4.11.7.3. Use the appropriate qualifier in N101 and N103 to identify WAWF-iRAPT, EDA, and the AAI.

C4.11.7.3.1. To identify WAWF-iRAPT, use N101/RGA and N103/93.

C4.11.7.3.2. To identify the AAI, use N101/CW and N103/PI.

C4.11.7.3.3. To identify EDA, use N101/EM and N103/94

C4.12. <u>CANCELLATION OF A UNILATERAL PURCHASE ORDER NOT ACCEPTED</u> BY THE CONTRACTOR

C4.12.1. As required by FAR 13.302-4(b), contracting officers will notify the contractor in writing that the purchase order has been cancelled and request the contractor's written acceptance of the cancellation. DFARS PGI 213.307-3 requires that unilateral purchase orders be cancelled with a contract modification.

C4.12.1. As permitted by FAR 13.004 the Government may unilaterally issue an award in response to a vendors quote. Such awards are not binding contracts until acceptance by the vendor either in writing or through performance. As such, there are sets of contracts that remain open in Defense business systems even though no deliveries or work has or will ever occur. C4.12.2 provides the mechanism for identifying and closing these unfulfilled awards in order to free obligated funds and stop perpetuating these extraneous contract files. Contracts identified as unfulfilled, should be administratively closed in accordance with FAR42.302(a)(63).

C4.12.2. A cancelation of a unilateral purchase order not accepted by the contractor will be submitted using Code H in 1/CS05/050.

C4.12.3. This procedure applies to both automated closeouts systemically initiated by iRAPT, as well as all other non automated closeouts submitted by other systems.
