4. REQUESTED CHANGE(S):

a. <u>Brief Overview of Change</u>: This change is an administrative change to update the title of DLM 4000.25 Chapter 12 (Reference 3.a.) and replace the term "advance receipt information" (ARI) with the more common term "pre-positioned material receipt" (PMR). This will be a global change in the chapter as part of the next DLMS Manual update. EBSO will do a

global change throughout the DLM 4000.25 Manuals to update any remaining occurrences of ARI to PMR.

- **b.** <u>Background</u>: While creating the DLMS Manual chapters, the term ARI was introduced in an attempt to modernize the term PMR. The term ARI was not widely adopted within the DOD logistics community and PMR continues to be the preferred term. Recent ADCs, including ADC 1269 (Reference 3.b.) included an administrative update to replace the term advance receipt information (ARI) with the more common term pre-positioned materiel receipt (PMR) used in the DLM 4000.25-2 MILSTRAP Manual.
- **c.** Requested Change in Detail: This change will update DLM 4000.25 Volume 2 Chapter 12 title and replace the term "advance receipt information" (ARI) with "pre-positioned materiel receipt" (PMR). This change also applies to all occurrences of the term ARI throughout the DLM 4000.25 manuals.

d. Revisions to DLM 4000.25 Manuals:

(1) Revise DLM 4000.25 Volume 2, Chapter 12 title to "Due-In And Pre-Positioned Materiel receipt replacing ARI as shown:

C12. CHAPTER 12

DUE-IN AND ADVANCE RECEIPT INFORMATION PRE-POSITIONED MATERIEL RECEIPT

- (2) Revise DLM Volume 2, Chapter 12 to replace all occurrences of "advance receipt information" with "*pre-positioned materiel receipt*" and replace the acronym "ARI" with "*PMR*".
- (3) Execute a global search throughout the DLMS Manual Volumes to find all occurrences of advance receipt information (ARI) and update them to *pre-positioned materiel receipt (PMR)*. These changes will be made in conjunction with the next formal change cycle but will not be incorporated as part of the formal change documentation.
 - (4) Revise the DLM Volume 2 Table of Contents for Chapter 12, as shown:
