4. REQUESTED CHANGE(S):

a. <u>Brief Overview of Change</u>: Update the General Services Administration (GSA) logic in the Type of Fill Table used to categorize Planned vs. Unplanned Direct Vendor Deliveries (DVDs). Significant changes from the original version of this change issued as a PDC are highlighted in Green highlight.

b. **Background**:

- (1) LMARS uses "Type of Fill Criteria" to determine the applicable reports in which each document number, completing a pipeline segment within the report month, is included. The usage and detailed procedures for the LMARS "Type of Fill Criteria" are available on the EBSO Website.
- (2) Available LMARS report categories, based on the currently deployed Type of Fill table include: Immediate Fill, Back Ordered, Planned DVD, Unplanned DVD, and Other. Current rules in the Type of Fill table apply all of these categories to GSA shipments. GSA closed all of its warehouses and now fulfills all shipment requests using an "all_DVD" fulfilment paradigm. As result, GSA does not issue any Immediate Fill, Backordered, or Other shipments, and the only currently correct GSA types of fill are Planned DVD and Unplanned DVD. Because the type of fill table does not reflect "all DVD" paradigm, LMARS, and subsequently other down-stream reporting systems (e.g., the Supply Chain Metrics Group (SCMG) Dashboard), incorrectly report GSA shipment types. This results in underreporting of GSA DVD shipments, and reporting of GSA Immediate Fill, Backordered, and Other shipments that do not exist.
- (3) Additionally, all Backorder (BB) status codes for GSA Inventory Control Point (ICP) will be identified as Planned DVD. GSA's use of BB status Code requires a contract to be in place. There may be instances when the acquisition advice code (AAC) can differ from "H" in LMARS for BB status. In those instances, the category will always result in Planned DVD as long as the status is BB.
- **c.** Requested Change in Detail: The requested changes to the LMARS Type of Fill Table are detailed in the enclosure.
- (1) Enclosure Displays the "Type of Fill Criteria" Table with the approved changes from GSA.
 - (a) The rows in "red" are to be added to the table.
 - **(b)** The strikethroughs are to be deleted from the table.
- **d.** Revisions to DLM 4000.25 Manuals: Revise "LMARS Type of Fill Table," as shown in the Enclosure (DLM 4000.25, Volume 6, Chapter 4, paragraph C4.6.3.1.1).

- **5. REASON FOR CHANGE:** To correct the inappropriate categorization of GSA's Planned and Unplanned DVDs.

- a. Advantages: Correctly identifies GSA Planned and Unplanned DVDs. Enables correct calculation of the LMARS metrics, which provide input to downstream reporting systems such as the SCMG dashboard. This change will enable GSA clearly to identify performance metrics changes resulting from its decision to close its warehouses and move to an all DVD fulfilment paradigm. This change will enable DOD to access and use correct metrics to measure GSA system performance against goals.
