#### 4. APPROVED CHANGE(S):

**a.** <u>Brief Overview of Change</u>: This approved change increases the cost threshold to remediate discrepant packaging for all DLA owned material from \$300 to \$1000 per supply discrepancy report (SDR). This change also removes the DLA managed clothing and textile commodities specific \$500 threshold. There is no change or impact to Service owned material.

- **b.** <u>Background</u>: Currently, DLA Distribution Centers remediate packaging discrepancies to include markings/labels that are under \$300 and submit the SDR back to the owner for informational purposes. In November 2019, DLA leadership increased the threshold for all DLA owned materiel to \$1000 dollars.
- **c.** Approved Change in Detail: Administrative change to the document which increased the threshold for the cost to remediate packaging for DLA owned materiel. This proposed change removes the \$500 threshold for DLA managed clothing and textile commodities. All Service owned materiel will remain at the current threshold of \$300 dollars per SDR.
- **d.** Revisions to DLM 4000.25 Manuals: Administrative change only to Defense Logistics Manual (DLM) 4000.25, Defense Logistics Management Standards (DLMS), Volume 2, Chapter 17, Supply Discrepancy Reporting, as shown in the enclosure.
- **e.** <u>Approved Transaction Flow</u>: Standard SDR business transactions and procedures apply.

- 5. REASON FOR CHANGE: Administrative only
- 6. ADVANTAGES AND DISADVANTAGES:
- **a.** Advantages: Allows DLA owned materiel that is under the repackaging threshold dollar amount to be placed in a ready for issue condition and available to our customer requisitions. Also avoids materiel from being suspended and unavailable for long periods of time.

- 4. If the cost of correcting the packaging is less than \$1000, DLA can make the correction without notifying the owner beforehand and submit the SDR after the correction has been made, correct?
- 5. If the material is service owned and the cost of correcting the packaging is more than \$300, the service has to be notified, correct?
- 3. This PDC is only applicable to DLA owned materiel. It does not apply to Service owned materiel regardless if DLA is the manager.
- 4. The SDR is submitted at time of receipt, materiel stays in an issuable condition and is remediated at time of receipt.
- 5. If the materiel is service owned and the cost of correcting the packaging is more than \$300, an SDR is created and sent to the owner and materiel is suspended.

C17.3.2.8.2.1. For DLA-managed-owned materiel only, if the cost to correct the discrepant packaging of materiel received by the DLA Distribution Center has a PMR on file, no item discrepancies are noted, is a secondary item is less than \$3001000, the DLA Distribution Center may perform the corrective action without authorization from the owner.
