- **a.** <u>Brief Overview of Change</u>: This administrative change will delete DLMS notes the 511R Requisition and 511M Requisition Modification added from ADC 466 (Reference 3.B) that allowed Reutilization Transfer and Donation (RTD) Web to calculate transportation costs for FMS customers.
- **b.** <u>Background</u>: In 2012, ADC 466 updated the DLMS 511R and the DLMS 511M with DLMS Note 2 that states "Authorized DLMS enhancement for DLA Disposition Services to provide fund cite for FMS transportation billing." (Reference 3.b.). In 2018, DLA Disposition Services submitted a new change, staffed under ADC 1156A (Reference 3.C) that resulted in EBS performing the FMS transportation calculations which uses the DLMS 940 transaction opposed to RTDWeb. This administrative change removes the DLMS note on the 511R and 511M transactions that states RTD Web will perform calculations for transportation costs identified as Funds Appropriation, i.e. Fund Cite or Line of Accounting.
- **c.** <u>Approved Change in Detail</u>: Revise the DLMS 511M and 511R notes, as shown in the Enclosure.
