- Precious Metals Recovery

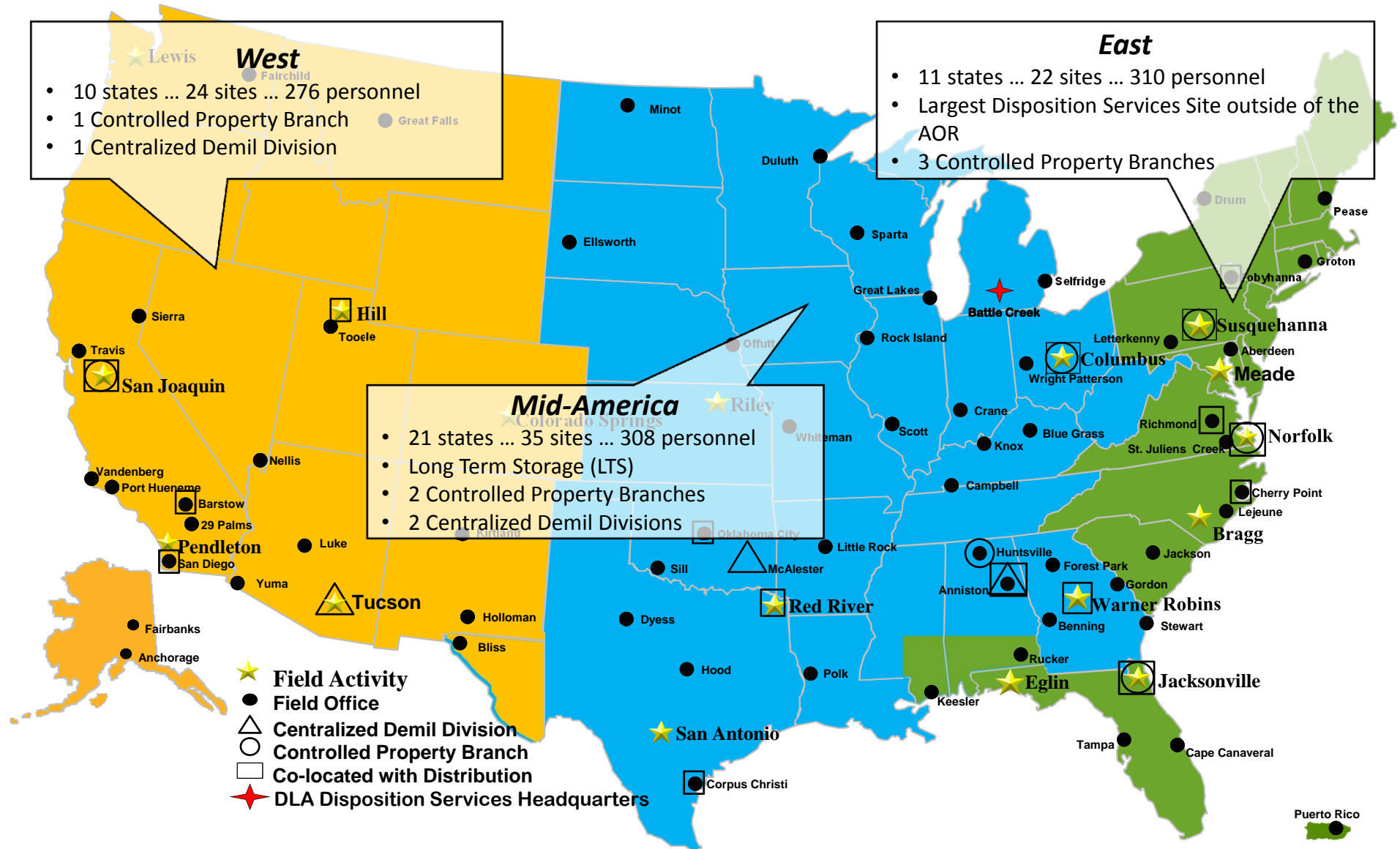

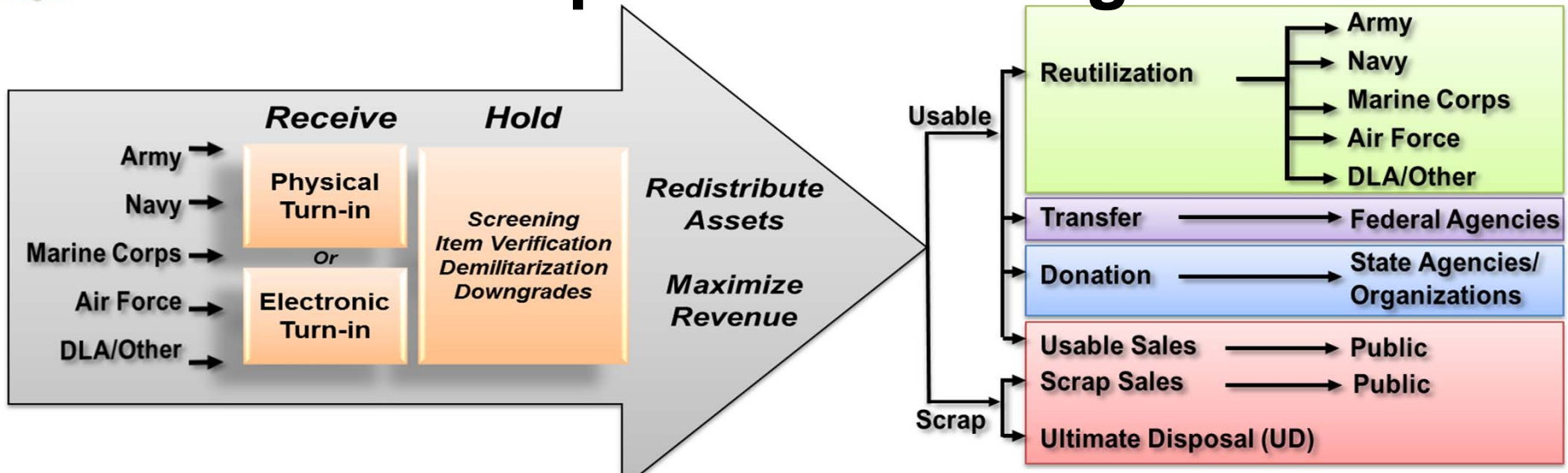

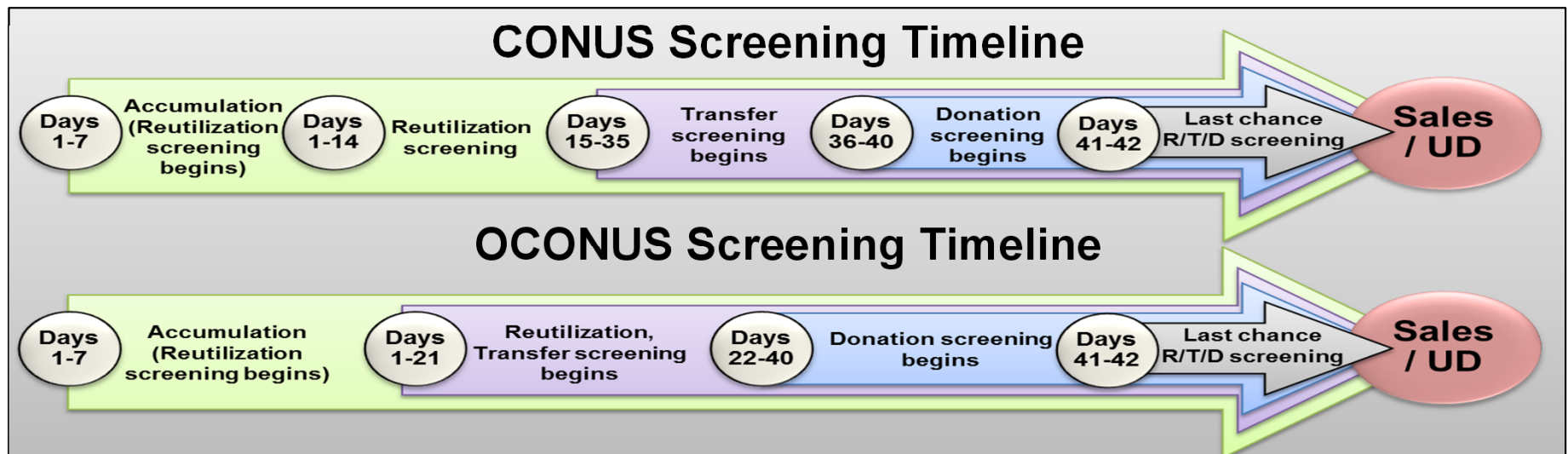




Disposal Screening

Request for Technical Proposal

- Request For Technical Proposal (RFTP) (Step one)
 - Two requirements to be invited to participate in Step two

Requirement 1:

- Recycler must be R2 or e-Steward certified
- No requirement to show relationship



RFTP requirements

- Request For Technical Proposal (RFTP) (Step one)

Requirement 2:

- Demonstrate the ability to process up to 100,000 lbs of DEMIL/DEMAN electronics
- Demonstrate the ability to process up to 480,000 lbs of Non-DEMIL electronics
- Provide a scaled facility drawing
- Surveillance plan
- Lighting plan
- Security plan
- Safety plan

No requirement for minimum number of facilities

Technical Proposals are due 17 Sept 2015



Invitation for Bid (IFB)

- What are we selling? Electronic material both DEMIL required and non-DEMIL required.
- Eastern Region – All states East of the Mississippi, Puerto Rico and the U.S. Virgin Islands
- 24 month performance period
 - 3 option periods of 12 months each
- 100,000 lbs of DEMIL required property weekly
- 480,000 lbs of non DEMIL property weekly
 - Volume may go up or down and may have surges
- Guarantee 5 million lbs
- Buyer can shred and sell or sell as an item (computer, copier)
- Only financial requirement is the Bid Deposit (\$100,000)



Invitation for Bid (IFB)

- Bid based on % of AMM No. 1 Copper wire (Chicago)
 - Use the lower end of the range scale displayed.
 - AMM range is \$2.00-2.20
 - Your bid: 10%
 - Monthly weight is 10,000 lbs
 - \$0.20 X 10,000
 - Bill for the month = \$2,000
- DEMIL Property
 - Must have complete oversight, 100% of the time
 - Destruction must take place within 5 days after inventory



IFB review

- Contract terms:
 - 24 month initial term
 - 3 twelve month option periods
- Estimated Weights:
 - East
 - 25 Million lbs annually
 - Guarantee 5 million lbs
 - 4.3 million lbs of DEMIL material



IFB review

- Contract terms:
 - Payment determination
 - Based on Copper price in AMM on the 5th of the month
 - Site visits
 - Pre-Award Survey at proposed DEMIL site(s)
 - Can visit any recycle center used to process Govt property
 - Title Transfer
 - Non-DEMIL will transfer with material
 - DEMIL title will transfer after Govt receives Destruction Cert
 - Do Not Sell (DNS) & Returning of property
 - Govt will provide a DNS list to contractor
 - Should material become or is strategic, Govt will request its rtn



Site Visit Info

- Contract Terms:
 - Reports
 - Type of each material recovered
 - Gold
 - Silver
 - Aluminum
 - Plastic
 - Etc
 - Classified inventory report
 - Secure material immediately
 - Notify SCO for directions



Site Visit Info

- Contract Terms:
 - Accommodating Govt Personnel at DEMIL site
 - Office space, phone, desk, internet
 - Must be onsite



Site Visit Info

- Contract Terms:
 - Must maintain R2 through-out life of contract
 - Breach of contract and Cure notice
 - 30 days to rectify
 - Prohibited activities
 - No partnerships that assign responsibility to another party
 - DoD investigations or on-site visits
 - Recycle...Recycle...Recycle
 - Dunnage, plastics metals



Site Visit Info

- DEMIL Requirements
 - Cradle to Grave accountability
 - Must be inventoried upon receipt
 - Must be destroyed...no matter how insignificant or how cool
 - 5 days from receipt and inventory
 - Weighed after destruction for billing
 - Title transfer after Govt receives certification of DEMIL
 - Required area large enough to spread material out and inventory
 - Must be a secure area.
