EASY STREET JD&S, LLC (Easy Street)

1) CONTRACT AWARD

a. This contract constitutes the Government's acceptance of the Contractor's offer, including all revisions that were approved and accepted by the Government, under Requests for Proposals (RFPs) SPE8EC-17-R-0004, as amended by Amendment 0001 and Amendment 0002. It is an Indefinite Delivery/Requirements Contract under which the Contractor shall function as a supplier for Cranes.
