All terms and conditions of the contract remain the same, except as follows:

Contract clause 52.212-4 Contract Terms and Conditions – Commercial Items, Addendum paragraph (t)(5) is hereby changed as follows: delete the no-later-than time requirement for all requests for price changes submitted via the 832 EDI transaction set from "Thursday, 1:30 PM Philadelphia time" and replace it with "Wednesday, 1:30 PM Philadelphia time".

Additionally, any and all other references in the contract specifying the time requirement for all 832 price change requests shall be revised to Wednesday, 1:30 PM Philadelphia time, for price changes effective the following Sunday.

The above change to the contract is made at no change in contract price.
