OPTION YEAR 4

1. The Government hereby renews subject contract and invokes the fourth option period, June 20, 2008 through June 19, 2009. The fourth option period also applies to administrative contracts SPM300-08-D-3243 and SPM300-08-D-N067.
2. The guaranteed minimum is ten percent (10%) of the estimated value of the fourth year option, or \$3,000,000.00.
3. The distribution prices for the fourth option period will remain the same as in the third option period.
4. Clause 52.217-9P16 "Effective Period of Contract – Indefinite Delivery, Indefinite Quantity Contract" is modified to read:

"The effective period of this contract is from June 20, 2008 through June 19, 2009."

5. Clause 52.216-18 (a) "Ordering" is modified to read:

"Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders by the individuals or activities designated in the schedule. Such orders may be issued from June 20, 2008 through June 19, 2009."
