VENDOR QUESTION:** Understanding this follows under FAR 52.212-4, CONTRACT TERMS AND CONDITIONS – COMMERCIAL ITEMS (JUNE 2013), the list of requirements as stated under (1) are for the invoices that ultimately are submitted to DLA Troop Support for processing and not applicable to the invoice requirement for submission of a proposal for the Price Proposal for SPM300-13-R-0078 correct?

DLA Troop Support Answer: Yes. This does not apply to the invoices that need to be submitted as part of the submission requirements.

- 2. VENDOR QUESTION:** (1), (ix) Taxpayer Identification Number (TIN). The contractor shall include its TIN on the invoice only if required elsewhere in this contract. The question as it relates to the TIN, is this actually required? I searched, read and see nothing requiring the TIN. However, realizing we are dealing with FAR's and such, is this requirement embedded in a FAR that I'm not aware of within SPM300-13-R-0078?

DLA Troop Support Answer: The Taxpayer Identification Number (TIN) is not required by any other part of the solicitation. Please refer to "ADDENDUM TO FAR 52.212-4 Contract Terms and Conditions – Commercial Items" on page 13 of the solicitation and also Attachment 4 – EDI Implementation Guidelines which details the segments and their definitions for Transaction Set 810.
