The following revisions apply to the solicitation:

1. On Page 165, Part 8 Submission Requirements, Paragraph F, add the following note at the end of the third paragraph:

Invoices should reflect prices effective within forty-five (45) days prior to the date specified for receipt of offers (initial or revised, whichever is later). If invoices are not available for that time period, a quote should be obtained and submitted. **Note: Therefore, offerors should not submit product price quotes or invoices as part of their final proposal revision due on November 17, 2010.**

Please note that all other terms of the October 20, 2010 letter remain in effect. Most importantly, price revisions are prohibited unless you can provide documented evidence showing a direct link between changes in your proposal resulting from Amendment 26 and the October 20, 2010 letter's clarifications and the proposed pricing.

The deadline for the submission of your Final Proposal Revision in response to your letter dated October 20, 2010 is not being changed. Your written Final Proposal Revision must be submitted No Later Than 12:30 P.M., local Philadelphia time on Wednesday, November 17, 2010 via email to linda.ford@dla.mil.

Any revisions to your proposal received after 12:30 P.M., local Philadelphia time on Wednesday, November 17, 2010, will be treated in accordance with FAR Clause 52.212-1, Instruction to Offerors – Commercial Items (June 2008) under (f) Late Submissions, Modifications, Revisions, and Withdrawal of Offers and the addendum to paragraph (f) Late Submissions, Modifications, Revisions, and Withdrawals of Offers, as specified in the solicitation.
