

1. The purpose of this MOD is to correct the clause (**DSCP 52.217-9P12**) on page 34 of the solicitation to match Amendment 18 page 27, paragraph number 71 and page 52 of the Contract Award document under "Award Details".
2. Delete and replace DSCP 52.217-9P12 paragraph (c) with the following language:

**DSCP 52.217-9P12(c) OPTION FOR INDEFINITE-DELIVERY, INDEFINITE-QUANTITY
CONTRACT TERM EXTENSION (MAR 2004)**

c) The contracting officer may extend the term of this contract for four (4) additional option period(s), the first three options are one year each and the final or fourth option is 18 months by written notice by close of business to the contractor within three (3) days before the expiration date of the contract, provided that the contracting officer shall give the contractor a preliminary written notice of intent to extend at least 60 days before expiration of the contract. The preliminary notice does not commit the government to an extension.
