REQUIREMENT FOR: Full Food Line Distribution for U.S. Forces and other authorized customers in Kuwait, Iraq, and Jordan.

1. This modification invokes the second 12 month option period of the contract cited in accordance with Clause 52.217-9P12 - Option for Indefinite Delivery, Indefinite Quantity, Contract Term Extension (March 2004) DSCP.

2. The contract performance period is hereby extended from midnight EDT (Philadelphia) on 13 March 2013 through 11:59 PM EDT (Philadelphia) on 12 March 2014. Total estimated contract value for this second option period is \$359,394,045.98. The minimum of the second option period is 1%, or \$3,593,940.46.
