The paragraph on page 96 of the solicitation/contract regarding the dating requirement for UGR-A's is revised to read as follows:

"UGR-A's will have at least 9 months shelf-life remaining when delivered by the Government to the Contractor's facilities. Remaining shelf-life shall be determined by the Inspection Test Date (ITD) marked on the side of each case in a MM/DD/YY open date format. UGR-A rations delivered by the Contractor to the Ordering Activities shall have no less than 30 days remaining shelf- life at time of delivery, unless otherwise directed by the DLA Troop Support- COR or UGR-A COR."

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
