The Lead Times for Zone 1 – Japan is hereby modified to read:

1. Land Customers – Skip Day
2. Market Ready (highly perishable FF&V) - 72 hours for regular orders and 7 days lead time for large orders (over 1,000 cases).
3. Home Ported Ships
 - Small Ships Regular Daily Orders - Skip Days
 - Small Ships Deploying - 7 days
 - Large Decks (CVN/L Decks) Regular Daily Orders - 7 days
 - Large Decks Deploying - 45 days
4. Transient (visiting) Small Ships - 21 days (due to the nature of their orders are usually large after their last port call or RAS).
5. Large Deck Transient Ships (CVN's and L Decks) - 45 days will provide CPF/D with ample time to ship from their West Coast supply line.

NOTE: Any unforeseen situation should be covered by airlift request.

All other terms and conditions remain unchanged.
