Contract SPM300-09-D-3272 is hereby modified as follows:

The Second Option for a Twelve (12) month Period under subject contract is hereby exercised. The option period is May 12, 2013 through May 11, 2014. The estimated dollar value of this second option is \$16,253,024.00. The Guaranteed Minimum value is 10% of the Option value or \$1,625,302.40 and the Contract Maximum is 175% of the Option value or \$28,442,792.00.

The distribution prices for all items during the option period will remain unchanged except category 25 (Fruits, Juices, Nectar, Vegetables - Chilled) which will decrease from _____ and category 31 Dairy Foods - (Eggs, Egg Products, Yogurt, Sour Cream, Cheese, Milk - Fresh, Chilled, or Frozen), which will decrease from _____

The Small Business Goal has increased to 40% for the 2nd and 3rd option periods as stated on page 2 of the contract.

The previous modification issued for this contract was P00028. Modification numbers P00029 to P00200 were skipped over due to renumbering in Eprocurement, our new writing system. All future modifications after P00201 will follow sequential order without skipping numbers.

All other terms and conditions remain unchanged.
