REQUIREMENTS FOR: OKLAHOMA AREA

Contract SPM300-09-D-3272 is hereby modified to incorporate the changes as outlined on pages 4 and 5 of this modification.

The Third Option for a Eighteen (18) month Period under subject contract is hereby exercised. The option period is May 12, 2014 through November 14, 2015. The estimated dollar value of this third option is \$24,379,536.00. The Guaranteed Minimum value is 10% of the Option value or \$2,437,953.60 and the Contract Maximum is 175% of the Option value or \$42,664,188.00.

The distribution prices for all items during the option period will remain unchanged except for category 31 Dairy Foods - (Eggs, Egg Products, Yogurt, Sour Cream, Cheese, Milk - Fresh, Chilled or Frozen), which will decrease from /CS to S.

All other terms and conditions remain unchanged.
