2. Solicitation SPE300-16-R-0023 is hereby amended to allow for samples on Lot 3 to be submitted on October 7, 2016, in addition to the samples submitted on Lots 1 and 2. The option remains to submit samples on Lots 1 and 2 on October 7, 2016 and Lot 3 on October 10, 2016. Any sample for Lots 1 and 2 submitted after October 7, 2016, or for Lot 3 submitted after October 10, 2016, will be considered late and will deem the offeror not eligible for award on the respective lot(s).
3. The deadline for notification of failure and resubmission of samples is 12:00 pm Eastern time. Resubmission of samples are due by 4 pm on the following business day when notification is made by 12:00 pm. If notification is made after 12:00 pm, product resubmission of sample(s) will be required on the 2nd business day by 4:00 pm. Notification will be considered to have occurred when the government representative contacts the POC listed on the case label of the product sample.
4. The item description for Line item 2-13 on Attachment 1 is amended as follows:
BEEF FAJITA STRIPS, RAW, FROZEN, USDA Select Grade, seasoned, 1/2 inch by 1/2 inch with 2.5 inch minimum length, vacuum packaged, 5 or 10 pound bags, 1/40 pound case.
5. The Line item number for the fully cooked ground beef patty sample submission, identified as item 3-10 in Amendment 0002, is corrected to read 3-11. The item description in Amendment 0002 is correct. Samples should identify the line item number as 3-11.
6. A copy of the revised spreadsheet "Attachment 1-Schedule of Items 9-29-16 - Amendment 0003" is included in this amendment and replaces all previous versions.
7. A manufacturer's product specification sheet for each sample shall be submitted on or before the due date of sample submissions. The sheets are to be sent to Timothy.Dlugokecki@dla.mil, Zoraya.Wilson@dla.mil and Nancy.Hildreth@dla.mil.
8. The labels on each product sample submission will be evaluated for compliance with FSIS mandated and DLA OCONUS mandated label requirements.
9. Offerors are required to provide advance notice of shipment of the samples by providing an electronic copy (PDF) detailing, at a minimum, the carrier name, lot number of sample(s) and a tracking number via email.
