

In preparing Mod P00008 – update to Mod P00007, please concur with the following bilateral administrative changes to the contract:

1. Effective 20 AUGUST 2015, please remove Eileen Friel from the contract and replace with Timothy B. Dlugokecki as the new Contracting Officer.
2. Change Effective Date of the previous EPA Quarterly Price Update (Mod P00007) to reflect new effective dates 7 June 2015 through 5 September 2015. Please note, the next quarter is defined as 6 September 2015 through 5 December 2015; these dates are the first day of the STORES catalog pricing updates for all OCONUS Prime Vendors. The ending date for the current prices shall be SEP 05, 2015 ILO SEP 04, 2015. Quarterly effective periods shall be the First Sunday of the Month (FSOM) thru the last Saturday of the month that precedes the FSOM for the subsequent quarter.
3. With regard to Amendment 003, question 37 “Will the awardee be subject to the DLA Worldwide Audit Program, please remove the answer “No” and replace with the following answer “DLA will not audit product at any manufacturing facility as part of its Worldwide Audit Program. The Worldwide Audit Program is designed to audit SPV purchased product at its OCONUS warehouse facilities. It is the product at SPV facilities which is being audited. The goal of the program is to ensure that our DoD customers are receiving products at an optimal quality level and that there is no product misrepresentation or unapproved substitution.”
