Page 16 of 137, H.4.b., Delete second sentence and insert "Under no circumstances shall any meat or meat product be used beyond the manufacturer's recommended shelf life or 365 days, whichever is shorter".</p> <p>C. Page 16 of 137, H.4.c. (2), Delete "180 days after slaughter" and insert "365 days after slaughter or the by the manufacturer's recommended shelf life, whichever is shorter".</p> <p>D.
