CLIN 0003 is added as Meal, Individual Pork-Free, NSN 8970-01-623-9560. The maximum quantity for CLIN 0003 is 2,000,000 CS. CLIN 0003 shall be made in accordance with ACR-M-034, except that all pallets shall consist of 48 cases of only case "A" and shipped as full pallets. The new NSN shall be marked on the shipping case.

All other terms and conditions related to CLIN 0001 pertain to CLIN 0003 as well.
