- b. Page 14, TABLE III, Menu 23, Delete "Cookies, Sugar, Patriotic" and insert "Cookies 1/"
- c. Page 15, TABLE IV, Cookies, Menu, insert "23".

The recommended change will not have a negative impact on the nutritional content of menu 23.
