1. In Section L, on page 167, 1.0 Product Quality/Product Demonstration Models (PDMs), paragraph 1, sentence one, delete:

“Vendors must submit PDMs for the FSR.”

And replace with: “Vendors must submit PDMs for CFM items in the FSR, except for mandatory source items.”

2. In Section L, on pages 175-176 following changes are to be made:

Under #1, after “...available at http://www.DLATROOP_SUPPORT.dla.mil/subs/fs_check.pdf” insert:

“If an acceptable Product Protection Plan including Product Protection Plans covered in the QSP (Quality System Plan) was previously submitted to DLA Troop Support, the offeror does not need to submit another Product Protection Plan with their offer. However, the offeror shall submit a letter to DLA Troop Support with their offer identifying the office, name of the person the plan was submitted to, date of submittal, and rating assigned to their previous Product Protection Plan.”

Under #3, after “...the inventory monitored, etc.)?” insert:

“If an acceptable Integrated Pest Management Plan was previously submitted to DLA Troop Support, the offeror does not need to submit another Integrated Pest Management Plan with their offer. However, the offeror shall submit a letter to DLA Troop Support with their offer identifying the office, name of the person the plan was submitted to, date of submittal, and rating assigned to their previous Integrated Pest Management Plan.”

3. The closing date for this solicitation SPM3S1-12-R-7104 has been extended to December 5, 2011.

All other terms and conditions of the solicitation remain unchanged.
