PKG & QAP A-A-20177E w/Change 01 27 May 2010, paragraph B, Packaging for Type XII, Style B for FSR Mints states that the filled and sealed pouch shall have dimensions of not more than 2-1/2 inches wide by 4-1/2 inches long OR the commercial blister pouch shall have dimensions of not more than 1-3/4 inches wide by 3-3/4 inches long. However, commercially acceptable packaging is acceptable, regardless of the dimensions, as long as the product fits in the Accessory Packet. If the dimensions are greater than those outlined in the specification and the package does NOT fit in the Accessory Packet, it is the responsibility of the offeror to repackage the mints, at no cost to the Government, in order to fit in the Accessory Packet.
