**Survival Food Packet, General Purpose - Improved  
Procurement Verification Inspection**

1.0 **PURPOSE:** To establish standardized procedures for the Survival Food Packet, General Purpose - Improved (GP-I) in-plant/procurement food safety and quality assurance functions.

2.0 **SCOPE:**

2.1 This procedure applies to current and future Army Veterinary Inspectors (AVIs) that are tasked with the additional responsibility to perform GP-I in-plant/procurement food safety and quality assurance functions.

2.2 This document discusses situations, procedures, and inspection guidance not covered in DSCP Handbook 4155.2 or applicable appendices. However, DLA Troop Support Handbook 4155.2, Appendix G will be very useful.

5.0 **PROCEDURES:**

**NOTE:** The most active bidder for the GP-I contract is New View Oklahoma, Oklahoma City, OK. The Oklahoma Branch, PHCD Ft Hood, PHCR South is tasked with this additional inspection responsibility.

**OPERATIONAL RATIONS INSPECTION PROCEDURE (OPRATS IP25)**  
**1 March 2013**

5.1 The Branch will maintain a current “Controlled Copy” of the SRAO IPs. These IPs are also posted in the restricted access OLB Procurement Lotus Notes DB.

5.2 The DVC will contact the Chief, Operational Ration Section, USAPHC, through the RVC, at DSN 471-6209, commercial (210) 221-6209, or Lotus Notes email for access to the restricted Survival Ration Procurement databases for the AVIs selected to staff the mission. The restricted access Survival Rations Procurement databases are as follows:

5.3 The use of the Survival Rations Procurement databases is discussed in the SRAO IPs.

5.4 The AVIs given access to the restricted Survival Rations Procurement databases are strongly encouraged to review all documents posted in the various restricted databases prior to performing the mission.

5.5 The Chief, Operational Rations Section, USAPHC, will train the selected AVIs at the contractor’s facility during the first week of production, if needed.

5.6 When the AVIs are at the contractor’s facility, the AVIs perform the food safety and quality assurance functions directly for the Chief, Operational Rations Section, USAPHC.

5.7 The AVIs will refer to the Chief, Operational Rations Section, USAPHC, any disputes, disagreements, contractual interpretation, etc. between the contractor and the assembler.

**6.0 RECORDS, REPORTS AND FORMS:**

6.1 A CVR will be completed for each ration inspection to establish a record in the ISP application and capture the manpower required.
