1. The purpose of this modification is to award 3 new production test ration entrée items to the current contract.
2. Subsequent delivery order for the production tests will be issued.
3. No other changes apply.

This is an award of a production test for 3 new items under a newly developed PCR. The purpose of the production test is to enable the Government to evaluate the PCR under production conditions to determine its adequacy and industry's ability to produce these items. You are required to produce the required quantity in such a manner that performance will be on consecutive days (Monday thru Friday) for a period of not less than seven hours a day until the required quantity is produced. You are required to permit Government personnel designated by the Contracting Officer to observe the entire production and will provide all reasonable facilities and assistance to enable these persons to achieve their purpose of determining the adequacy of the PCRs. Changes to the PCRs must be authorized in writing by the Contracting Officer or representative designated in writing to act for and in his/her behalf in such matters. Production Tests are tentatively scheduled for June/July 2013.

Production/delivery under this contract is required NLT August 31, 2013. In the event production cannot commence when scheduled, the Contracting Officer will be so notified as soon as possible. The Government reserves the right to unilaterally revise the Production Test Schedule after award, at no additional cost to the Government. You are required to provide data such as production planning documents and product formulations including ingredient certifications for each ingredient (CoC or other form) to the Government Production Test Team prior to the start of the actual production.

This production test award does not guarantee an award under full production.
