

**2. Functional Area:** Supply

**3. Requested Change:**

**a. Title:** Removal of the Materiel Receipt Acknowledgement (MRA) Exclusion for Navy Manual Ships,

**b. Description of Change:** This administrative change removes the MRA exclusion for Navy manual ships.

**c. Procedures:**

(1). Revise DoD 4000.25-2-M, Military Standard Transaction Reporting and Accounting Procedures (MILSTRAP), as being amended by Formal Change 5, chapter 6, section C (Exclusions), to delete paragraph C.9 as follows:

***~~"9. — Navy manual ships."~~***

(2) A corresponding change will be made to DoD 4000.25-M, Defense Logistics Management System (DLMS), volume 2.

**4. Reason for Change:** Per the Naval Supply Systems Command November 13, 2000, electronic mail (enclosure), Navy has determined that an exclusion from MRA procedures for Navy manual ships is no longer required. All Navy afloat units operate under one of several systems and have 100% MRA capability.

**5. Impact:**

**a. Publications:** DoD 4000.25-2-M (MILSTRAP), DoD 4000.25-M (DLMS), and Service/Agency publications as applicable.

**b. Systems:** No known system impact.
