

MEMORANDUM FOR: DISTRIBUTION

SUBJECT: Approved DLMS Change 47, Revised Service Code L
Usage (Supply/ MILSTRIP)

This change to DoD 4000.25-1-M, Military Standard Requisitioning and Issue Procedures (MILSTRIP) and DoD 4000.25-M, Defense Logistics Management System (DLMS), authorizes use of Service Code L by the USMC in the assignment of Routing Identifier Codes for contractors. This change is effective 30 days from the above date.

Revised Service Code L Usage**

1. ORIGINATOR:

- a. **Service/Agency:** USMC LPC-3

2. FUNCTIONAL AREA: Supply

3. REQUESTED CHANGE:

- a. **Title:** Revised Service Code L Usage
- b. **Description of Change:** This change authorizes assignment of Service Code L for USMC routing identifier (RI) codes for contractor use only.
- c. **Procedures:** Revise Appendix AP2.2, Service and Agency Codes as follows:

4. REASON FOR CHANGE: Currently, Service Code M is being used to identify both Marine Corps sources of supply and civilian contractors. In order to accommodate the fielding of the new Medium Tactical Vehicle Replacement (MTVR), USMC requests the assignment of Service Code L for use in the RI code field of transactions by civilian contractors (Oshkosh) supporting the Marine Corps. The support for the MTVR will be the model for the USMC Contractor Logistics Support initiative. (In addition, publication of this change corrects an administrative error in the above appendix that misplaced the L for rp 74.)

5. ADVANTAGES AND DISADVANTAGES:

- a. **Advantages:** Once approved, the USMC will be able to migrate towards a seamless, transparent order and payment system. All contractors supporting the Marine Corps will gradually migrate towards the L_ series of RI codes.
- b. **Disadvantages.** Implementation of this change may result in potential conflicts with intra-Component use or unauthorized uses of Service Code L.

6. IMPACT:

- a. **Data Content/Procedures:** Currently used unauthorized RI code assignments with Service Code L should be phased out to preclude future conflicts. Requires minor program changes to recognize Service Code L assigned RI codes as USMC contractors.
- b. **Publications:** DoD 4000.25-1-M, MILSTRIP; DoD 4000.25-1-S1, MILSTRIP Routing Identifier and Distribution Codes; DoD 4000.25-M, DLMS
