
MEMORANDUM FOR SUPPLY PRC MEMBERS

SUBJECT: Approved DLMS Change 48D, Addendum for Revision to DLMS Supplement (DS): 945A, Material Release Advice (Supply)

This addendum provides a revision to the DoD 4000.25-M, Defense Logistics Management System (DLMS), modifying the DS 945A, Material Release Advice. This change is to be incorporated with Approved DLMS Changes 48/48A/48B/48C during implementation. This change is required to support continued logistics operation in a DLMS/DLSS environment.

The updated DS will be posted to the DLMSO web site (<http://www.dla.mil/j-6/dlms/ICs/Default.htm>) within 30 days from the above date for implementation planning. DLMSO will concurrently pursue coordination/approval with the DoD Logistics Functional Working Group, the DoD Electronic Data Interchange Standards Management Committee (EDISMC), and the Federal EDI Standards Management Coordinating Committee (FESMCC) for Federal implementation convention (IC) revisions.

4. REQUESTED CHANGE:

a. **Title:** Addendum for Revision to DS 945A, Material Release Advice

b. **Description of Change:** This change modifies the DLMS Supplement (DS) 945A Material Release Advice to support DLMS/DLSS conversion and make administrative corrections. The “must use” designation is removed from the date/time segment in the detail level and associated notes are adjusted. Additionally, the capability to pass the Special Requirements Code (containing coded entries from the Required Delivery Date field) is provided on an interim basis to support conversion.

c. **Procedures:** Revise DS for 945 A, Material Release Advice as follows.
