

SUBJECT: Approved DLMS Change 90, Inclusion of Special Unit Price for U.S. Marine Corps Coding (Supply)

3. REQUESTED CHANGE:

a. **Title:** Revision to DLMS Supplement 869F for Inclusion of Special Unit Price for U.S. Marine Corps Coding

b. **Description of Change:** The U.S. Marine Corp requires inclusion of a special unit pricing to support system requirements to adequately process supply transactions using EC/EDI processes. This change allows this unit price to be reflected in the GF segment.
