

MEMORANDUM FOR: SUPPLY PRC MEMBERS

SUBJECT: Approved DLMS Change 62, for Revision to DLMS Supplement (DS) 856R,
Shipment Status Material Returns (Supply)

This change to the DoD 4000.25-M, Defense Logistics Management System (DLMS), modifying the DS 856R, Shipment Status Material Returns, is required to support continued logistics operations in a DLMS/DLSS environment. A corresponding change to the Federal implementation convention (IC) will be prepared; however, this is not necessary for immediate update of the DS. The revised DS will be posted to the DLMSO web site (<http://www.dla.mil/j-6/dlms0/ICs/Default.htm>) within 30 days.

2. FUNCTIONAL AREA: Supply

3. REQUESTED CHANGE:

a. Title: Revision to DS 856R, Shipment Status Material Returns

b. Description of Change: This change modifies the DS 856R to add an additional code required to support DLMS/DLSS conversion and intended DLMS functionality.

c. Procedures: Revise DLMS Supplement for 856R, Ship Notice/Manifest as follows:

Does <u>not</u> require Federal IC change prior to DS update.

d. Alternatives: None identified.

4. REASON FOR CHANGE: This change supports DLMS implementation and desired functionality. The missing code was identified during testing of conversion processing. The DI Code FTM may contain a Media Status Code entry which requires status to the activity represented by the M/S Code; therefore it is necessary to provide an

N1 qualifier to identify status recipients.

5. ADVANTAGES AND DISADVANTAGES:
