MEMORANDUM FOR: SUPPLY PROCESS REVIEW COMMITTEE (PRC) MEMBERS

SUBJECT: Approved DLMS Change 70, DLMS Mapping for DLA Directed Material Release Order (MRO) (Requisition), DI Code C0A/C01, and DLA Directed MRO (Referral), DI Code CQA/CQ1 (Supply)

This change to the DoD 4000.25-M, Defense Logistics Management System (DLMS) is approved for implementation. This change is required to support continued operations in a DLMS/DLSS environment. The updated DLMS Supplement will be posted to the DLMSO web site (<http://www.dla.mil/j-6/dlms/ICs/Default.htm>) within 30 days from the above date for implementation planning. DLMSO will concurrently pursue coordination/approval with the DoD Logistics Functional Working Group, the DoD Electronic Data Interchange Standards Management Committee (EDISMC), and the Federal EDI Standards Management Coordinating Committee (FESMCC) for Federal implementation conventions (IC) revisions.

The attached change to DLMS will be incorporated into the DLMS manual/supplement, based upon the effective or availability date to be determined. **NOTE:** DAAS and DLA have advance authorization to employ these procedures during Business Systems Modernization (BSM) testing; however, configuration management/version control procedures must be observed allowing for sequential implementation to prevent rejection.

3. REFERENCE: DLA Manual 4140.2, Vol II, Part 3

4. REQUESTED CHANGE:

- a. **Title:** DLMS Mapping for DLA Directed MRO (Requisition), DI Code C0A/C01 and DLA Directed MRO (Referral Order), DI Code CQA/CQ1

b. **Description of Change:** This change accommodates the Business Systems Modernization (BSM) SAP requirement for conveying directed MRO data. This change modifies the IC/DS 511R, Requisition, to transmit the data content of the DLA DI Code C0A/C01 and CQA/CQ1. The directed MRO passes from the Inventory Control Point (ICP) to the Distribution Standard System (DSS) storage activity. Inclusion of these data elements supports DAAS conversion from the DLMS transaction originated by BSM to the DLA unique transaction required by the receiver. The process addressed by this change is commonly referred to as “post-post.”

Description of “Post-Post” Transactions: A “post-post” issue involves accepting and updating records after the event (or issue) has occurred. In a typical example, a Call Center, Item Manager or Defense Distribution Center Customer Service receives a request or sales order off line. For various reasons, these requests are received through a transmission medium other than Defense Information Systems Network (DISN) (e.g., fax, phone, email, etc.). Directed MROs may be entered off line by the ICP Emergency Supply Operations Center as emergency “post-post” MROs when the total requisition quantity can be filled from a single DSS storage site, using the DSS-directed MRO entry process. The DSS process allows an ICP user to sign on to a DSS storage site to input directed MRO data online. Upon acceptance of the directed MRO, DSS will generate a “post-post” MRO transaction and route it through DAAS to the applicable ICP. Upon receipt of the “post-post” MRO transaction, the transaction will be processed in the ICP system as a directed “post-post” requisition or “post-post” referral order for the quantity, Ownership/Purpose Code, Condition, and location identified. No MRO will be generated.

c. **Procedures:** Add the following codes/notes to the 511R DLMS Supplement.

d. Alternatives: BSM could perpetuate use of the post-post transactions as currently formatted.

5. REASON FOR CHANGE: This change supports component-level DLMS implementation for the DLA BSM effort. These data elements and codes were identified during a review of DLA-unique transactions.

6. ADVANTAGES AND DISADVANTAGES:

- a. Advantages:** Supports component-level DLMS implementation.
- b. Disadvantages:** None identified.

7. IMPACT:

a. Data Content/Procedures: May require minimal update to DAAS and DLA BSM mapping.

b. Publication(s): DoD 4000.25-M, DLMS, Federal IC 940R and corresponding DS. The DS revision requires corresponding revision of the Federal IC. All applicable revisions will be submitted to the EDISMC/Logistics Functional Work Group for coordination/approval.
