


The proposed CMMC rules were published in the Federal Register and comment period ended on October 15, 2024. At this time, it is difficult to estimate when the rule will become final. DLA will have a better estimate once the public comment period has closed and comments have been adjudicated by the DFARS drafting team, and any changes to the rule are incorporated into the draft DFARS text. A plausible effective date could be late spring or summer of 2025. We will provide guidance once we get more information.
