Modification Overview

Modify is a menu option in LESO FEPMIS that is used to submit property modifications (i.e., property attributes, transfer property), to accept/deny property transfers or to split an assigned quantity of a property number.

Can

- Transfer property (In-State only)
- Accept property transfers
- Change National Stock Number (NSN)
- Add/change Serial Number (SN)
- Add a physical storage location
- Submit Splits

Can't

- Change property number
- DEMIL Code
- Unit of Issue
- State to State property transfer
- Change item cost

LESO Modification Approval

Attributes Approval

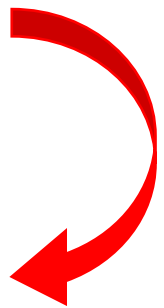

Split is used to separate items for turn-in or transfer from a larger quantity. Modify is used for the split process.

- Example - 35 upper handguards are under a single property number. 10 are required to be sent to a different agency.
