

As the DLA lead for the Print on Demand (PoD) initiative for geospatial products, we offer printing services of unique customer needs. Products are provided at no cost when ordered through DLA MCO because we operate under appropriated funds. Please order only the necessary products and quantities.

# **Product descriptions:**

Aeronautical products display map features of the earth, including selected terrain, cultural and hydrographic features.

- terrain, cultural and hydrographic features, along with is supplemental information for air navigation, pilotage and planning air operations.
- Digital products are aeronautical,

  hydrographic and topographic products
  available on CD-ROM.
- Hydrographic products display water depths, bottom and coastlines contours, and tides, and currents for marine or coastal areas.
- Topographic products display the measurable vertical and horizontal positions of physical and culture features, including locations, elevations and extent.

DLA Distribution Mapping receives, stores and ships many of the products managed by MCO. There are also nine forward presence DLA activities throughout the world to aid in timely deliveries to worldwide customers. Many are colocated with PoD facilities.

#### MCO MAP ACCOUNTS

To obtain mapping products from MCO, customers must first register and then request the MEBS Prod - Mapping Enterprise Business System Customer MEBS-99 role in the Account Management & Provisioning Sytem (AMPS) at https://amps1.dla.mil. This is a two-step process. Once registration and role request have been completed/approved in AMPS, customers will be able to access the Mapping Enterprise Business System (MEBS) to complete the final steps for establishing their map account.
