• Proper packaging allows quicker processing of receipts and faster receipt of material to customer





- Effective May 6, 2019, DLA will discontinue its 2-day accelerated payments.
- It is DLA's intent to minimize any disruption by continuing to accelerate payments <u>ahead of</u> the contract payment terms.
- Small businesses should begin to receive 15-day accelerated payments after May 6, 2019.





- DLA Aviation is requiring requests for post award action to be submitted through the PAR feature.
- A job aid entitled "Post Award Requests (PAR) in DIBBS 2018" is located at:
  - http://www.dla.mil/HQ/InformationOperations/Business/EBSSupplierR esources.aspx.
- When the supplier submits a PAR for a post award action, the request is automatically displayed in the contract administrator's workload, along with any attached documents. The supplier can then use the feature to track the progress of your request. It eliminates having multiple communication avenues, such as email and phone calls, for the contract administrator and the supplier to monitor.

Rule eases requirement that service-disabled vet make *all* decisions

Defines "extraordinary circumstances" in which non-SDV can have shared decision making authority
Control can shift when veteran is called to active duty
If service-disabled veteran rated at 100 percent, surviving spouse can own and control for up to 10 years after veteran's death

- Class Deviation 2019-O0003, Revision 1 Limitation on Subcontracting for Small Business was issued on January 8, 2019.
- The deviation updates the limitations on subcontracting and the non-manufacturer rule for all small businesses in clauses related to set-aside and sole source awards under FAR Part 19.

# **New Definitions**



# Limitation of Subcontracting (applies to manufacturers)

For supplies (other than acquisition from a nonmanufacturer of the supplies):

- the contractor will <u>not pay more than 50 percent of the amount paid by the Government</u> for contract performance, excluding the cost of materials...
- to subcontractors that are <u>not similarly situated entities</u>.

# Similarly situated

- A subcontractor with the same small business program status as the prime contractor and
- The similarly situated entity must also be small for the NAICS code that the prime contractor assigned to the subcontract (i.e. HUBZone requirement = a subcontractor that is a qualified HUBZone small business; SBSA = small business concern; SDVOSB set-aside= SDVOSB subcontractor, etc

## Non Manufacturer Rule (applies to Dealer/Distributors)

A small business concern that provides an end item it did not manufacture...shall—

- Provide an end item that is domestically manufactured by a small business concern
- Be primarily engaged in the retail/wholesale trade and normally sell the type of item being supplied; and
- <u>Take ownership or possession of the item with its personnel, equipment, or facilities in a manner</u> <u>consistent with industry practice; for example, providing storage, transportation, or delivery.</u>





- Limitation of Subcontracting and Non-Manufacturer Rule does not apply for SBSAs <u>under</u> the simplified acquisition threshold.
- Since the non manufacturer rule does not apply under SAT, a small business can provide the product of <u>ANY</u> firm\*
- Limitation of Subcontracting and the Non Manufacturer Rule <u>DO APPLY</u> to subcategory setasides unless a non manufacture rule waiver applies no large business products unless waiver
   \*Rule of two still applies to set-asides



# **Set-Aside Criteria**



## > Micro (\$10,000.01) to SAT

Shall be set-aside for small business UNLESS the KO determines that there is not reasonable expectation of obtaining **offers from 2 or more** SB concerns.

- SB concern can provide any firm's product
- SB can provide <u>same manufactured product</u>
- No need for products of different concerns
- NMR waivers still apply

### **Subcategory Set Asides**

- Service Disabled Veteran: Sole source or Competitive (self certified)
- HUBZone: Sole source or Competitive (SBA certified)
- 8(a): Sole source or Competitive (SBA certified)
- Women Owned Small Business: Sole source or Competitive (NAICS specific)—SBA or Third Party Certified

### **Over SAT**

Set aside all acquisitions for small business when there is a reasonable expectation that offers will be obtained from

- At least two responsible small business concerns. And...
- Offering the products of different small business concerns

Need expectation of two SB manufacturers

## Subcategory Set-Asides (Under and Over) SAT

Must provide product of a small business manufacturer at any dollar value unless a NMR waiver applies

Can no longer provide large business product unless a waiver applies

Applies to sole source and competitive subcategory set asides
